

FORESTS ARE IN FLAMES

REPORTS FROM WISCONSIN POINTS ARE THAT THE FLAMES ARE SPREADING. TOWNS ARE IN GREAT DANGER. Big Fire Raging at Niagara, From Which Point an Appeal for Aid—Much Property Destroyed.

MARINETTE, Wis., April 30.—Forest fires raged furiously north of Fisher, Mich., along the right of way of the Wisconsin & Michigan railway Saturday and Sunday. The property damage will be large. The station, water tank and other property of the railroad company and a large section of the town belonging to the C. H. Webster company, at Ames, Mich., were destroyed by fire. The town was practically wiped out, entailing a loss of about \$20,000 or more.
