UNITED STATES DISTRICT COURT, District of Minnesota, Third Division. In the Matter of Henry S. Fairchild, Bankrupt.

To the Honorable William Lochren, Judge of the District Court of the United States for the District of Minnesota. Henry S. Fairchild, of the City of St. Paul, in the County of Ramsey and State of Minnesota, said bankrupt, respectfully represents that on the twenty-seventh day of April, last past, he was duly adjudged bankrupt under the acts of Congress relating to bankrupts; that he has duly surrendered all his property and rights of property, and has fully complied with all the requirements of said acts and of the orders of the court touching his bankruptcy.

Whereas he has ordered that a hearing be had upon the same on the 18th day of June, A. D. 1906, before said court, at St. Paul, in said district, at ten o'clock in the forenoon; and that notice thereof be published in the St. Paul Globe, a newspaper published in said district, and that all known creditors and other persons in interest may appear at the said hearing, and do hereby do so, and sign the following articles of incorporation:

ARTICLE I. The name of this Corporation shall be The Minnesota Guaranty and Surety Company. The general nature of the business of the corporation shall be buying, owning, leasing, selling, lending and pledging in lands, tenements and real estate and real, mixed and personal estate and property, and acting as agent for the buying and operating, buying, selling, leasing and pledging of real estate.

ARTICLE II. Said corporation shall commence on the fifth day of June, 1906, and the period of its continuance shall be thirty years.

ARTICLE III. The amount of the capital stock of this corporation shall be Thirty-five Thousand Dollars (\$35,000), and shall be divided into 350 shares, of One Hundred Dollars (\$100) each, of which \$10,000 shall be paid up at the time of incorporation as the Board of Directors of said corporation shall determine.

ARTICLE IV. The highest amount of indebtedness or liability to which said corporation shall at any time be subject shall be Twenty Thousand Dollars (\$20,000).

ARTICLE V. The names and the places of residence of the persons for said corporation for incorporation are as follows: Edwin W. Ware, George W. Ware and Howard F. Ware, all residing at St. Paul, Minnesota.

ARTICLE VI. The government of this corporation and the management of its business shall be vested in a board of three directors, which board shall have power, from time to time, on behalf of the corporation, and to cause to be executed, by the proper officers of said corporation, note or notes therefor, and a good and sufficient mortgage or mortgages upon all real estate owned by said corporation, to secure the payment thereof, upon such terms and conditions as to said board shall seem proper.

ARTICLE VII. The officers and directors of this corporation shall be elected by the stockholders of said corporation at each annual meeting of said corporation, and the first meeting of said corporation shall be held on the first Monday in May, 1906, at the principal office of said corporation, at St. Paul, Minnesota.

ARTICLE VIII. The office of president, secretary and treasurer, vice president, shall be elected by the stockholders of said corporation at each annual meeting thereof, and shall continue in office until their successors are elected.

ARTICLE IX. Any stockholder who shall hold one or more shares of the capital stock of this corporation at the time of the annual meeting of said corporation, and who shall be present at such meeting, or who shall be duly authorized by the stockholders of said corporation, may be held by the same person.

ARTICLE X. The first officers of the corporation shall be: President, Edwin M. Ware; Vice President, George W. Ware; Secretary and Treasurer, Howard F. Ware.

ARTICLE XI. And they shall hold office until the annual meeting of said corporation for the year 1907, or until their successors are elected in their stead.

ARTICLE XII. Special meetings of the Board of Directors or stockholders may be held at such times and under such rules as the Board of Directors may prescribe, and until such time as suitable by the Board of Directors.
