DAY'S NEWS IN BRIEF.

Dallas, Tex.—Fire at Durant, I. T., today destroyed property valued at \$100,000. The large portion of the business section was wiped out, insurance, \$40,000.

Cincinnati, O.—The United States circuit court of appeals has decided a question of boundary line between Tennessee and North Carolina in favor of Tennessee.


