### RICHEST TURF PRIZE.

#### Futurity of 1903 Will Probably Exceed All Previous Races.

The richest turf prize offered in this country will probably be the Futurity of 1903, to be run at the Grand National at Sheepshead Bay. The Coney Island Jockey club has announced that the estimated value of the race was \$75,000.

Ever since the first running of the Futurity in 1888, it has been the most valuable race in the money value of the American turf, and it has always attracted widespread interest, not only on account of its money value, but from bringing together some of the best fleet footed thoroughbreds in this section of the world. The distance of the race has always been 170 feet less than six furlongs.

#### Setters and Pointers Not Prominent in English Field Sports.

It is often a subject of lamentation in the columns of English sportsmen's journals that the "days of the dog in the field" are numbered. It is a fact that in England pointers and setters no longer figure prominently in field sports.

As a rule partridges are either "walked up" or "driven" over the heads of the men with the guns. When the former method of shooting partridges is followed, as is generally the case, the dog is not used, the stubble fields are walked over in the morning, the partridges feeding in them being driven to the cover and forced there by fields of turnips, manure, or mustard.

After this has been done the shooters walk up, with one or two beaters between each gun, and the turnip fields are walked over, the birds being close, but offering good open shooting. The only dogs used in such cases are those that have been taught to "sit" in the best results.
