ALL WOULD BE GRATEFUL PRESIDENT MCKINLEY YESTERDAY DENIED A FEW APPLICATIONS FOR PARDON

GRIGGS' TERSE STATEMENT

Discusses Practice of Convicted Murderers Whose Death Sentences Have Been Commuted Applying for Further Clemency.

WASHINGTON, March 22.—The president today denied seven applications for pardon and granted two petitions for the restoration of civil rights, remitted one fine, and granted one pardon on account of ill health.

Among the applications denied was that of Joe Martin, convicted of murder in 1887 and sentenced to hang, whose death sentence was commuted to life imprisonment by President Harrison.

It is obvious that there must be at some time a stop put to these numerous applications, which are made with frequency, for the pardon of convicted murderers to whom has been shown the clemency of commutation of sentence to imprisonment for life.

Among the applications granted was that of George L. Rice, editor of the St. Paul Globe, who was deported from the Philippines in consequence of articles published concerning Lieutenant Commander Bruner.

WASHINGTON, March 22.—Gen. MacArthur's report, giving the details of the deportation of the delegates from Occidental, who were ordered out of the Philippines in consequence of articles published concerning Lieutenant Commander Bruner.

The report of Gen. MacArthur was submitted to Judge Advocate General Lieber, who rendered an opinion that Gen. MacArthur acted wholly within his authority in the deportation of Rice.

RAZOR, Island of Negros, March 22.—According to expressions of a large majority of the delegates from Occidental, a few of whom were present from the Oriental side, the sentiment of the people is overwhelmingly in favor of the restoration of the Philippines to provincial governments in both divisions.

The reasons given for this view are that such a change will effect a reduction in the high salaries received by the officials of the schools and the improvement of the roads. SHORTS IN MAY PROVISIONS LIKE- LY TO BE SQUEEZED.

CHICAGO, March 22.—Rumors were rife on the Board of Trade today that Armour interests were engineering a deal in May which would bid fair to produce broader results than the persistently reported "squeeze" in May pork.

The Armour purchases of May ribs during the day amounted to over 5,000,000 pounds, which come near the limit of the supply in the city available for delivery.
