

REPORT THAT THIS ROAD IS IN FAVOR OF MELLEN-ROBLIN DEAL.

WORKS INGENUOUS SCHEME

Used Its Unpopularity to Delude the Public, and Outwardly Put Up a Fight Against the Government.

WINNIPEG, March 22.—(Special.)—Almost simultaneously with the announcement that the Canadian Pacific has withdrawn its opposition to the line which the Crow's Nest Coal company desires to build to the international boundary, comes a startling story to the effect that the same railroad company is in reality secretly in favor of the Mellen-Roblin deal. Of late it has been somewhat ostentatiously paraded that the Mackenzie-Mann magnates of the Canadian Pacific were at odds. The Canadian Pacific office in Winnipeg has been screeching itself hoarse in condemning the deal and tracing work have put themselves on record as being opposed to the course of the government on this point. Most of the gentlemen are either directly or indirectly connected with the Canadian Pacific and all through it has appeared as though the railway company was fighting the deal to a finish.
