





MR. WILSON, WHILE WAITING FOR BLANK CHECK FORMS, IS GATHERED IN

LOAN OFFICE IS SWINDLED

Arrested Man is Believed to Have Worked Clever Scheme by Diverting J. P. McMahon's Mail.

A young man whose name is believed to be Wilson, is under arrest charged with having unlawfully obtained from the St. Paul postoffice, and opened the mail addressed to another person. The complaint against Wilson is made by Assistant District Attorney Fred Dickson on information from Inspector Kimball, of the postal service, and Supt. Hadlich, of the delivery department of the postoffice, and it appears that the prisoner planned and executed a elaborate scheme of a fraud for the purpose of securing a loan of \$35.

It is alleged that Wilson first called at the Gray street station of the postoffice and left an order for a printed form provided for that purpose directing that the mail addressed to J. P. McMahon, 13 Poplar street should thereafter be delivered to Carroll street. Then a day or two later, it is said, the young man appeared at the central postoffice, and representing himself as J. P. McMahon, said that he had left an order for a change of address in the delivery of his mail, but had since removed to Minneapolis and would like to have his mail sent to 122 Washington street in that city. Wilson still there a letter addressed to J. P.
