CALL A CONVENTION

United Mine Workers Will Meet in National Session July 17

SIGNED BY MITCHELL

Whether or Not Bituminous Men Will Strike—There Are About 1,800 Voters.

INDIANAPOLIS, Ind., June 18.—An official call for a national convention of the United Mine Workers of America was issued this afternoon from the national headquarters in this city by Secretary-Treasurer Wilson. The convention will meet here July 17, to determine whether the soft coal miners of the country shall go on a strike to assist the striking anthracite miners of Pennsylvania.

The basis of the appointment of delegates to the convention is one for every 100 members of the local union or fraction over 50. This will make a convention of 1,800 delegates.

The voting strength of all locals is between 2,300 and 2,400. It is expected this convention will have a voting strength of 1,700 to 1,800. A majority can order a strike. A little over 500 can declare a strike. The anthracite regions cast 747 votes, Virginia 1,700, and the bituminous field 1,700 to 1,800.

At a stated at headquarters conditions are not satisfactory to miners in Missouri, Arkansas and Indian territory, and it is believed the delegates from those sections will vote for a strike. The call for the convention is addressed "To local unions of the United Mine Workers of America," and says:

"Directors of the U. M. W. of A. and 24 have requested the national president to call a special convention and you are hereby notified that a special convention of the United Mine Workers of America will be held in Indianapolis, Ind., commencing at 10 o'clock a. m., Thursday, July 17, 1902, for the purpose of considering a proposition for a general suspension of work by all bituminous miners of the United States in support of the anthracite mine workers who are now on strike."

BELLES COMMONER WON

RESPECT'S AMERICAN DERBY ENTRY CAPTURED TRIAL SPECIAL

Wyeth, in a Desperate Drive, Beat Out Lucien Appleby by a Nose—Jockey Winkfield Was Thrown and Badly Injured—Field of Seven Started—Race Won in a Gallop.

CHICAGO, June 18.—J. B. Respee's Belles Commoner, an outsider in the betting in the American Derby, which will be run here Saturday, won the Derby trial special today at Harlem. The colt ran a marvelous race, covering the mile and an eighth in 1:32.5, and won in a gallop by three lengths. John A. Drake's youth, in a desperate drive, beat out Lucien Appleby by a nose. Prowl, who was fourth, was beaten by three lengths. Cruzados, second choice in the American Derby, quit after he had run a mile.

The race came near causing the death of Jockey Winkfield. He had the mount on S. C. Hildreth's McChesney, who, coupled with Lucien Appleby, was held favorite at 1 to 2. At the half mile pole McChesney fell, throwing Winkfield against the rail. Winkfield's right leg was injured badly, and his collar bone was broken. McChesney slid about thirty feet, but was seemingly uninjured on arising, except for a cut on his nose. He limped slightly on arising, but the Winkfield will be unable to ride any more this season.

Field of Seven. The withdrawal of Abe Frank, Otis and Lord Quex left a field of seven to go to the post for the race, which was run as the field in order to escape a threatened rainstorm.

Hildreth's entry, McChesney and Lucien Appleby were made favorites at 7 to 10, with Cruzados second choice at 5 to 1. Belles Commoner came next in favor at 7 to 1. Wyeth was quoted at 12 to 1, and Prowl and Cruzados at 20 to 1 each.

After a delay of five minutes, the post the field was sent away to a good start. Prowl, the stand Glenswater was showing the way by a head in front of Belles Commoner, with Cruzados on the latter's saddle. Rounding the bend first turn Cruzados forged his way to the front and attempted to run away from the field, but was unable to get away from Glenswater.

Winkfield Injured. In the run down the back stretch Cruzados led by about half a length, with Glenswater second. Hildreth's entry, third, and McChesney fourth. The latter on the rail.
