

APPEALS ARE HEARD

OCTOBER TERM OF THE SUPREME COURT OPENS AT THE STATE CAPITOL

JUDGES SIT AT TABLES IN THE HOUSE CHAMBER

Courtroom Not Large Enough to Accommodate the Two Hundred Attorneys in Attendance—Cases of Convicted Minneapolis Police Officials Are Set for Hearing in November and December.

More than 200 attorneys attended the opening of the October term of the supreme court yesterday. Chief Justice Start and Justices Brown, Lewis and Lewis were on the bench, or rather seated in chairs at long tables which had been dragged into the hall of representatives to take the place of the bench, the supreme court room not being large enough to accommodate the members of the bar.

The afternoon session was devoted to hearing motions and other preliminary work. Justice Collins was absent, being in attendance at the G. R. national encampment at Washington.

The call of the 267 cases on the calendar proceeded with dispatch, and at the noon recess the cases had all been set. The court will hear cases for seventy-five days, the last cases being set for Feb. 14. The calendar was continued over the term, four dismissed, two stricken and thirty-five will be submitted on briefs.
