BEAUTIFUL HAIR SAVES WOMAN

Mrs. Taylor, Struck by Carriage Pole, Is Protected by Natural Adornment.

A large coil of auburn hair is all that saved Mrs. H. E. Taylor from instant death Monday evening.

While crossing Selby avenue, near Dale street, shortly before 6 o'clock, Mrs. Taylor, who is the wife of Rev. Dr. Taylor, pastor of the Universalist Church of the Messiah, was run down by Mrs. S. S. Welch's coach horses. The carriage pole struck her with great force, tearing her headgear and landing a terrible blow directly over the base of her skull.

A heavy head of auburn hair was wound in a coil about the place where the pole struck. It was all that saved Mrs. Taylor, for it acted as a protection, preventing a serious fracture of the skull, which would undoubtedly have resulted in death.

Mrs. Taylor was hurrying to her home at 833 Laura street when the accident occurred. It was dusk and she did not see the carriage as it rapidly approached. Fred Greene, a sister driver, did not see Mrs. Taylor until the horses were all but upon her.

Before he could reign up the spirited animals, the carriage pole struck Mrs. Taylor squarely. She screamed and fell to the pavement unconscious. To her cries were added those of several woman spectators. Mrs. Kitt, a sister of Mrs. Welch, who occupied the carriage, became faint from fright.

Greene was the only one who remained cool. While Mrs. Taylor lay screaming and calling frantically for him to save Mrs. Taylor from death, he reined in his steeds. So hard did he pull on the lines that the harness and both horses were prancing on their hind feet. Beneath them the unconscious woman lay.

OHAGE HAS EYE ON EDEN VALLEY

Threatens to Quarantine Against Town for Smallpox.

Nearby towns and cities that are lax in their relations regarding contagious diseases and the quarantining of persons so afflicted will receive special attention from the local health department if any of their victims wander into St. Paul.

"I had a talk with Dr. Bracken, of the state health department, yesterday," said the first town I found disregarding the quarantine regulations I would bar its citizens from St. Paul. There is considerable smallpox in the state just now and I don't intend to stand idly by and see it brought to this city."

Eden Valley, a small town on the Soo road, is particularly receiving the attention of Dr. Ohage, health officer here, because of its laxity in handling the several cases of smallpox that now exist in its midst. Dr. Ohage visited the town Sunday and says he informed the authorities that if any St. Paul case was traced to Eden Valley he would immediately issue a strict quarantine against the town.

Punishment is one of the safeguards the local health department uses liberally in combating smallpox, and the machines which provide the germ-killing vapor are in constant use. Every time a case of smallpox is located the town is thoroughly fumigated and the victim's wanderings for a week traced in order to vaccinate every person whom the victim came in contact with.

WANT BALLOT BOXES GUARDED

Police Detail Will Probably Be Provided During Rogers Wagener Recount.

It is likely that, at the hearing Saturday, before the district court, on the application of John Wagener for a recount of the vote for the office of clerk of the courts, police detail will be requested by one or both of the parties in interest for the purpose of guarding the ballot boxes until the recount is completed.

All the ballot boxes used in the late election are stored in the vault attached to the city clerk's office, a precaution always taken following an election. There they remain, as a rule, for a period of three months, to be later taken down to the basement and stored away with other relics.

While tampering would be attended with difficulties, yet the vault is by no means burglar proof or safe from persons with an object in view, and it is for this reason that the services of a special officer may be requested.

Edward G. Rogers, whose election is conceded by the official canvassing board, in his answer to Mr. Wagener's petition for a recount, says some of the ballots, now in the boxes were purposely marked and these he will ask to be thrown out, and that he thinks about 1,000 ballots were so treated.

KEROSENE NOT MADE TO START RANGE FIRES

Such is the Dictum of Answer Filed by Standard Oil Company.

If you use kerosene oil for starting a fire and get blown up it is nobody's fault but your own. That is the dictum laid down in the answer of the Standard Oil company to the complaint of Michael Moritz and Joseph E. Singer, who are suing the company for damages sustained by explosions, and whose cause was transferred recently to the United States court, and answers were filed yesterday.

The Standard Oil company denies that the oil sold by it was of any mixture of gasoline and other oils. It was, said the answer, pure kerosene, and of a quality within the provision of the state law. If it had been used as good kerosene of the quality named should be used, that is to fill lamps, instead of for the purpose of lighting kitchen fires, there would have been no accident of the kind complained of, and the Standard Oil company would not be a defendant in a suit for damages.

LAW SUIT REVIVES SENSATIONAL CHARGES

W. L. Keeffe's Action Against Bank Recalls D. M. Owens's Accusation of Jury Fixing.

Echoes of the charges upon which Dwight M. Owens was tried in the criminal court, and the sensational counter-charges made by Owens against William L. Keeffe, were heard before Judge Lewis and jury yesterday in the trial of the suit brought by Keeffe against the Second National bank. The complaint, answer and reply all allude to the charges, and it is expected that, although the testimony was tame enough yesterday, the ugly accusations made some time ago will be repeated.

Keeffe is suing the bank to recover \$3,989, which represents the amount paid out by the bank on the notes alleged to have been forged by Owens, and which Owens claims were made at Keeffe's behest. Keeffe is in the salary and business and also makes a claim of personal injury claims against railway companies. Owens was employed by him in placing loans and looking up the guarantors of loans. He procured fifty-eight loans which Keeffe claims were bogus. The bank paid money on the notes, thereby, according to Keeffe's complaint, exposing the existence of the borrowers. Keeffe had about \$4,000 in the bank at the time, and he is suing to recover the part paid out by the bank to alleged borrowers.

Owens was tried for forgery, and at his trial claimed that he made out the fictitious notes at Keeffe's command, and that the money thus obtained was used in fixing juries. Frank E. Hall, bookkeeper for Keeffe, was on the stand yesterday, explaining methods of keeping books and running the business.



The amount received for their services is expended for articles of food, and this is the reason storekeepers have been kept busy for the few days selling children 7 cents worth of sweet potatoes and other purchases of like character and amount.

The pupils at the various schools coming to school at 8 o'clock, near the buildings yesterday, and at each of the schools a row is set apart for the gifts. The donations include almost everything that a child has. One little tot at the Madison kindergarten yesterday gravely deposited on the desk of the teacher a small paper bag filled with coal.

Committees from the older pupils will begin the work of distributing the articles this afternoon, the teachers at each school having made a list of those to whom the donations shall be made.

In addition to the distribution of clothing and food, all the schools will participate in Thanksgiving day exercises today. The programmes at the schools include music and recitations by the pupils.

The schools close this afternoon and will not reopen until Monday.
