TWO NEW COUNTIES ARE PROCLAIMED

GOV. VAN SANT DECLARES CLEARWATER AND COLUMBIA LEGALLY DIVIDED

ATTORNEY GENERAL ADVISES ACTION

Proclamation Will Now Bring Case Before Supreme Court for Immediate Settlement—Citizens of Polk County Opposed to the Division.

The new counties of Clearwater and Columbia were proclaimed yesterday afternoon by Gov. Van Sant, upon the advice of Attorney General Douglas. Curiously enough the reason for the proclamation lay largely in the fact that no one knows exactly the status of the matter, nor will know, until the validity of the elections have been passed upon by the state supreme court.

For the purpose of giving opportunity for the exercise of an appeal to the courts more than for any other reason, the proclamations were made yesterday. Attorney General Douglas in one of his opinions says:

"Without expressing an opinion as to the single question remaining unanswered by the supreme court of the state, I submit that the only method of bringing the matter into the courts will be to decide that Columbia county, having a plurality of affirmative votes cast over each of its competitors, is entitled to be proclaimed a duly organized county. To decide that the propositions are not competing and therefore only a single proposition would cause a resubmission to the electors."

The question undecided by the state supreme court in the Red Lake county case and which is now a vital one, is this: Should not the votes cast against any one of the propositions submitted, be counted against the proposition receiving the highest number of votes, and the proposition having the highest number of votes be required to have a plurality over the sum of the negative votes cast? The attorney general in his opinion says:

"The court therein determined that Red Lake county, having received a plurality over the affirmative votes cast for each of its opponents, was duly organized and that the votes cast against any one of the propositions, did not operate to defeat the organization of Red Lake county."

"However, it seems to me, that if a plurality vote is deemed to be sufficient, it must be a plurality over, not only the affirmative vote cast in favor of each of the competing propositions, but also that such vote must be a plurality over the total vote cast against each of such propositions."

Strong objection was made before Gov. Van Sant Friday by the proclamation of Columbia county by residents of Polk county, but there was no objection to the proclamation of Clearwater on the part of the citizens of Beltrami county. The Columbia county proclamation will bring the matter into the courts at once.

CITIZENS ARE ENJOINED

JUDGE LEWIS GRANTS A RESTRAINING ORDER AGAINST CLEVELAND VAPOR CO.

TAXPAYER ASKS FOR INJUNCTION

Suit Is Brought in the Interest of the Western Street Lighting Company, Who Claim Contract Was Fraudulently Awarded to the Cleveland Company.

Judge Lewis, in the district court yesterday, granted a temporary injunction, restraining Robert A. Smith, as mayor, Matt Jensen, as city clerk, and Louis Betts, as city comptroller, from signing or executing in any manner the contract awarded by the common council to the Cleveland Vapor Light company for furnishing gasoline lights for the city for 1903.

The defendants are ordered to appear in court tomorrow afternoon at 2 o'clock and show cause why the injunction should not be in force during the pendency of a suit, which has been brought for a permanent injunction.

Suit was commenced against the city yesterday to have the contract with the Cleveland company annulled, on the ground that it was awarded through fraud, conspiracy and not in accordance with the requirements of the city charter. The plaintiff named in the suit is John F. Broderick, a taxpayer, although the suit is brought in behalf of the Western Street Lighting company, of Kansas City, Kan., who claim to have been the most responsible bidder for the contract.

The plaintiff asks judgment against the city and demands that the defendants be forever restrained from executing the contract with the Cleveland company, and that the latter company be restrained from attempting to carry out the contract.

D. W. Lawler and Ambrose Tighe appeared for the plaintiff, and the allegations as set forth in the complaint were covered several typewritten pages.



BOARD OF ELECTRICITY HOLDS A SESSION

Discusses Proposed Changes in the Existing Statutes—Wants to Embrace Duluth.

The state board of electricity held its quarterly meeting at the capitol yesterday for the examination of applicants for state licenses as electricians. Ten applicants in all were examined, the majority for journeyman licenses, and of these seven were given state permits. The number examined this quarter was slightly in excess of the number at the last session.

The board engaged in a short discussion of proposed amendments to the present law, the full consideration of which will be taken up at their next meeting. The amendments are for the purpose of correcting minor errors in the law and to extend the jurisdiction of the board to Duluth, now being confined to Minneapolis and St. Paul.

Oscar Clausen and Joseph Macaulay, of St. Paul; W. I. Gray, W. F. Carpenter and C. L. Pillsbury, of Minneapolis, the full membership of the board, were present at the meeting.

WANTS PAY FOR SKIRT TORN BY A SIGN

Young Woman Whose Draperies Caught in Projection Demands Damages.

Miss Laura Lehmann has commenced an action in Justice Mills' court to compel a Seventh street firm to pay her \$11.25 for a skirt which she alleges was torn by coming in contact with one of the small signs projecting from a building on East Seventh street. Miss Lehmann says the skirt cost her \$11.25, and was as good as new until she was passing the defendant's store, when she caught on a projecting advertising sign and was so badly torn as to be unfit for further use.

The woman says she related the circumstances to the proprietors of the store, and told them they might make a settlement with her without any trouble, but this they refused to do and the suit was commenced. The case was set for hearing for Dec. 26, which was somewhat disappointing to the plaintiff, who insisted upon having the matter disposed of immediately.

"My skirt was ruined and they will have to pay me for it; they know they are to blame. I don't see why the case couldn't be tried at once so I could have the money before Christmas."

It required some time for Justice Mills to explain to the plaintiff that the defendants were entitled to a continuance if they so desired, but the ardor of the plaintiff was not dampened in the least by her failure to secure immediate justice and she declared she would be on hand at the appointed time.

DANIEL KELLY DOES NOT LIKE COMPANY

Objects to the Statutes Passed on County Board by Grand Jury.

County Commissioner Kelly, whose term of office expires shortly, objects to the ordinance and resolutions which have been passed by the grand jury as a whole relative to its connection with the construction of the new county jail.

Mr. Kelly, who was appointed to succeed former County Commissioner Whitcomb, came to the board long after the new jail was arranged for and the bond issue authorized. Since that time he has been an obstructionist, standing out strongly against expenditures that he did not believe were right and it was this, he thinks, that assisted in bringing about his defeat for reelection. He is now trying to excuse the other members of the board, but he strenuously objects to being included in the general mismanagement that has been alleged.

CASH WITH A MALLET

Boy Refused Money Gives Parent Terrible-Beating and Then Demolishes Cash Register.

When Sevro Casello, a saloonkeeper, at Third and Washington streets, refused to give his son John a sum of money the boy wanted, yesterday afternoon, the son said to have pounded his father over the head with a mallet and then demolished the cash register with the same instrument. The boy was later treated and charged with assault, the complaint having been sworn to by the boy's father.

WANTS PAY FOR SKIRT TORN BY A SIGN

Young Woman Whose Draperies Caught in Projection Demands Damages.

Miss Laura Lehmann has commenced an action in Justice Mills' court to compel a Seventh street firm to pay her \$11.25 for a skirt which she alleges was torn by coming in contact with one of the small signs projecting from a building on East Seventh street. Miss Lehmann says the skirt cost her \$11.25, and was as good as new until she was passing the defendant's store, when she caught on a projecting advertising sign and was so badly torn as to be unfit for further use.

The woman says she related the circumstances to the proprietors of the store, and told them they might make a settlement with her without any trouble, but this they refused to do and the suit was commenced. The case was set for hearing for Dec. 26, which was somewhat disappointing to the plaintiff, who insisted upon having the matter disposed of immediately.

"My skirt was ruined and they will have to pay me for it; they know they are to blame. I don't see why the case couldn't be tried at once so I could have the money before Christmas."

It required some time for Justice Mills to explain to the plaintiff that the defendants were entitled to a continuance if they so desired, but the ardor of the plaintiff was not dampened in the least by her failure to secure immediate justice and she declared she would be on hand at the appointed time.
