PRESIDENT BETRAYED BY REPUBLICANS

Cuba Was Promised Reciprocity and Fails to Get It.

CHICAGO, March 21.—William E. Curtis, in a special to the Record-Herald, says: When Mr. Allison and Mr. Cockrell went to the White house to ask the president if he had any further committments to the senate before the special session adjourned, he did not ask them to express his thanks and tender his congratulations, as he did when the committee performed the same ceremony at the end of the regular session. It was noticed that the committee remained with him a very short time—not more than two minutes—and while the senators and the president are too discreet to reveal what occurred, it is suspected that there was a sharp exchange of left-handed compliments.

The president feels that he has been betrayed by his party in the senate. One of the two objects of the special session was to secure reciprocity in trade with Cuba immediately and the Cubans had a right to expect that the senate would act in good faith. The president had a right to expect the same treatment, but he did not get it. Cuban reciprocity was postponed for a year—perhaps indefinitely.

Whatever excuses or explanations may be made by Senators Allison, Aldrich, Cullom, Platt, of Connecticut, Hanna, Lodge and Spooner, who are responsible for the policy of the Republican majority, the pledges of the United States to Cuba have not been carried out. Neither of these gentlemen can deny that the Cubans expected, and had a right to expect, better treatment. Their congress ratified the treaty promptly.

It is now more than two years since we undertook to fulfill the pledges of President McKinley and the Republican party to give the Cubans the benefits of a reduction in the duties imposed upon their products by our tariff and to secure for our manufacturers important advantages in their markets. This had been tried by legislation and by treaty, and notwithstanding the Republican party, the Republican administration and the Republican majority in the senate promised the Cubans reciprocity, not next year, but now, and the Cubans don't get it. They may get it next year, but they need it now and they have done their share toward the arrangement of an exchange of trade promptly and in good faith.

During the last political campaign we heard a great many political speeches from the Republican leaders on the subject and nearly every Republican state convention passed resolutions in favor of Cuban reciprocity. Utah, I believe, was the only exception. Mr. Allison, the Republican leader of the senate, for example, gave us an eloquent argument in favor of Cuban reciprocity and nearly two-thirds of his Republican associates made strong speeches in favor of the policy. If the constitution prohibits them from carrying out their pledges by means of a treaty, why did the Republican senators permit the president and secretary of state to mislead the Cuban government? The treaty was made at their suggestion. Are they honest but ignorant, and was it necessary for them to wait for senator Gorman to assume the leadership of the Democrats in the senate and to teach the Republicans of that body their duty and the constitutional limitations under which they labor? Senator Gorman is the only person at the capitol who comes out of the affair with any credit. He is representative of the present situation. The policy which the Republicans of the senate adopted toward Cuba was suggested by him in a Democratic caucus.

BERLIN, March 21.—Experiments have been made before representatives

HELPING IMMIGRANTS ENTER UNITED STATES

Those Afflicted With Disease Assisted by a Hospital Guard.

HALIFAX, March 21.—A plot to smuggle immigrants suffering from disease into the United States is believed to have come to light through the arrest today of a Russian named Tolstoy, a guard in the immigrant hospital here. The charge is that Jacobate accepted money from detained immigrants, receiving treatment in Niagara Falls, to permit them to escape. It is said he has confessed that he was working, in conjunction with others, to get such persons into the United States.

TOOTHsome TASK OF A BROTHERLY ATHLETE

Novel Trip Across Niagara Falls With a Man on His Back.

NEW YORK, March 21.—For a wager of \$200 and expenses, Otto Peters, a Brooklyn athlete, will try to cross Niagara Falls on a three-quarter inch wire, carrying another man of his own weight. Unlike Blondin, he will make the trip by clinging with his teeth to a leather strap connected to the wire by a small roller. The other man will sit in a chair strapped to the strong man's body. The wire is to be stretched directly over the main fall. The journey will be about 1,000 feet, and Peters expects to traverse this distance in from five to seven minutes. He plans to perform the feat within the next two weeks, and declares it will be easy.

OBJECTS TO "PARSIFAL" BEING GIVEN IN NEW YORK

Widow of Wagner Threatens to Prosecute Director Conried.

BERLIN, March 21.—The announcement that Director Conried intends to produce "Parsifal" at the Metropolitan opera house, New York, has attracted much interest in musical circles here. Many people regret his decision, believing Wagner's wish to confine performances of "Parsifal" to Bayreuth ought to be respected. Nevertheless, Count von Fossart, the intendant of the Royal theater at Munich, has already announced that he intends to produce "Parsifal" after the copyright expires.

Frau Cosima Wagner, widow of the composer, has telegraphed to the Boerssen Courier: "Have protested against Conried's purpose to produce 'Parsifal' as being lacking in reverence and illegal, and have ordered his prosecution if he produces it."
