

NEARLY 5,000 VOICES UNITE IN SONG PROGRAMME

Great Northeastern Sangerfest Begins Its Twentieth Triennial Session at Baltimore...

BALTIMORE, Md., June 14.—The formal opening of the twentieth triennial sangerfest of the Northeastern Sangerbund of America took place here this afternoon...

The seating capacity of the auditorium of this immense structure is 16,000 and the entire space was occupied, there being 5,000 singers on the stage and 9,000 persons seated on the floor...

This afternoon's concert was mainly a welcome, designated as a greeting from the Baltimore singers to the singing society guests from other cities...

Among the distinguished guests who will be present at tomorrow night are included President Theodore Roosevelt, who will make an address...

A proposition to change the by-laws so that the fest should be held quadrennially instead of triennially was voted down.

At the conclusion of the meeting dinner was served at Harmon's hall. At the meeting tonight of the delegates representing all the societies affiliated with the Northeastern Sangerbund, it was decided to inaugurate the next triennial sangerfest in Newark, N. J.

The appointment of an advisory committee of three to act in conjunction with the music committee in the selection of the prize songs was left to the directors of the sangerbund.

Prof. W. Edward Heimendahl, of the Peabody conservatory of music, this city, was selected to take the place of Dr. Hans Hartan, of Munich, as a member of the college of judges.

The reports of the various officers and committees were read and accepted.

This was done, and the attorneys argued the case before Judge Redwine. Two of the most interested spectators were County Judge Hargis and Sheriff Ed Callahan. The attorneys argued that the most important witness held by Maj. Allen, as they were witnesses in the Jett and White cases for the defense, was the man who saw the case for the commonwealth and Maj. Allen, against whom the habeas corpus proceedings were brought.

The grand jury meets tomorrow, and Judge Redwine said these cases could be taken before that body. The Haddicks boys and Luntze fully identified the men and they claim to know members of the Ewen family saw them come out of the house. It is supposed that the men saw the lawyers and then made their escape. Then men evidently knew the construction of the house. There was no fire in any of the flues in that section of the building. Howard Pulks, a boarder, heard persons come up stairs hurriedly and run down again.

Fire Is Incendiary.

The burning of Ewen's hotel is considered not only as incendiary, but also as accessory to other acts of intimidation connected with the pending trial of those accused of the murder of J. B. Marcus, who was an attorney for the contestants for the county of Lewis, now held by the order of the court with which the defendants were identified. It had been openly predicted that arson would go along with assassination, disciplinary measures might be needed in Breathitt county. It is now stated that other witnesses of the commonwealth are not property owners, but jurors who could not be found when detachments of troops were trying to bring them into court, are property owners.

The burning of Ewen's property not only has renewed fear for both life and property, but it has also led to the general outpouring of conviction of either of the prisoners.

Try to Bribe Ewen.

Several days ago a man visited him at his home and made a proposition that if he would repudiate what he had testified to on the witness stand, stating that he testified to what was not true because of the excitement he was under, he would be given \$5,000 by a certain prominent citizen, and if he did not accept this offer he would be assassinated. He encouraged his caller to return in the afternoon and mentioned two witnesses in a closet who overheard the repetition of the offer and threat, which was accompanied by five \$1,000 notes. No one has doubted that Ewen was in actual danger, but few were prepared for a step as desperate as that which came today, and is generally believed that the incendiary fire was due to the statement made to State Inspector Hines about the attempted bribery as well as to Ewen's testimony.

Feared to Send Soldiers.

Ewen, while seeing all he had in flames, and not knowing whether his family had escaped, did not leave the protection of the camp believing that his assassination would be attempted if opportunity was offered.

Shelter had to be furnished for the family and boarders by neighbors. The soldiers did all they could to extinguish the fire. It was feared to send any men on regular duty as a rush on the camp might be attempted and the fire was extinguished by the soldiers from the jail. Ewen and his family were found. The water barrels around the hotel, which had formed its chief protection, had been overturned.

JACKSON, Ky., June 14.—The fire threw a community accustomed to violence into unusual excitement, which continued tonight. Ewen, those who have tried to be neutral in the Breathitt county troubles are apprehensive that their homes may be the next to be burned.

All dreaded the coming of night. The provost marshal has only a handful of men, and should it be decided by contributors to the provost marshal's fund, as he believed to be many who would attempt to execute the order. All citizens are advised to act on any vigilance committee.

Oil Upon Fire Brings Death

Two Killed, Many Injured in Explosion in Milwaukee Residence.

MILWAUKEE, Wis., June 14.—An explosion caused by pouring kerosene in a lighted stove at the store and residence of John Brozokowski, 1404 Mitchell street, today resulted in the death of two persons, the probable fatal injury of one other and the burning of six more to such a degree as to require the attention of physicians. So great was the force of the explosion that the entire structure between the house and the store was blown from the house and two rooms were filled with flames, causing the fire department to work for an hour before the fire was extinguished.
