

WHEAT REPORTS FROM AVERAGE YIELD OF GOOD QUALITY

Comprehensive Reports From Grain Regions Show That Condition Is Much More Favorable Than Generally Believed—Harvest Under Way.

Wheat of excellent quality and a fair average yield is the general report of the Northern Pacific report issued yesterday, although there is a wide diversity of reports from the various states.

Grain has matured slowly on account of the cool weather, but has filled out splendidly. Harvesting has begun in some places, and will be general by the latter part of the week.

Rains have delayed harvesting east and south of Staples, in the Red river valley and from Mandan to De Smet, and the weather has been too cold for corn, and the crop is expected to mature if there are no heavy early frosts.

Harvesting of oats, barley and rye is finished, or well under way, and the yield is good.

The St. Paul-Duluth division reports much improvement in the potato crop, due to dry weather, but about Anoka farmers fear they will rot in the ground.

The report in detail says: Line East and South of Staples—Rains during the week delayed harvesting in some places; meadows flooded. In Lincoln, Minn., little hay will be cut. Farmers near Anoka expect fair crop of potatoes. Unfavorable weather for corn. Expect fair crop of wheat per acre. Lincoln expects only one-half crop wheat on account of the Wisconsin line. Potatoes harvested at Elk River averaging fifteen to twenty bushels per acre. Fair crop of all grains expected.

Staples to Moorhead—Grain maturing slowly on account of cold weather. Harvesting well under way this week. Audubon reports not so good crop of wheat as last year, but wheat is well. Hawley expects fair average crop. New York Mills reports average yield per acre. Staples expects ten to sixteen bushels wheat yield per acre. Potatoes harvested at Elk River averaging fifteen to twenty bushels per acre. Fair crop of all grains expected.

St. Paul-Duluth Division—Weather conditions more favorable than last week. Potatoes doing well. In Lincoln, Minn., farmers now able to go into their fields and meadows. Haying in progress. Good and fair doing in the north. Potatoes harvested at Elk River averaging fifteen to twenty bushels per acre. Fair crop of all grains expected.

Little Falls and Dakota Branch—Favorable weather for maturing grain. Burrum reports yield per acre of wheat per acre of last year's crop. Harvesting well under way. Weather too cool for corn.

Red River Valley Branch—Rains during the past week have delayed harvesting somewhat, but no damage done. Barley about an average crop. Wheat is now being harvested and will be good. Corn is expected to do well. It is turning out well and promises fair yield. Rain has helped potato crop and a good portion of the wheat crop. It is expected that it will mature with anything like favorable weather. Several crops of corn, but expected to come out all right.

Dakota Division—Heat harvest is now general and heads are well filled. Excellent crop is expected and will account for weather. Corn doing fairly well. Some barley has been threshed in. Wheat crop very light.

F and S. W. Branch—Harvesting being pushed as rapidly as possible, and some threshing has been done. That wheat crop is expected to be good. Barley averages about twenty bushels per acre in vicinity of Sheldon. Corn and flax doing well under favorable weather conditions.

Casselton Extension—Conditions on this branch are good. Considerable wheat has been cut and is of good quality. Some fields averaging twenty to twenty-five bushels per acre. Weather conditions favorable.

Cooperstown Branch—Harvesting has been delayed on this branch by the heavy rains. Barley and wheat will be fair crop and wheat is of good quality.

Jameson Branch—Threshing of wheat has begun and is turning out much better than was expected. Flax doing well and is of good quality. Recent rains have had beneficial effect.

Mandan to Dickinson—Harvesting is general throughout this branch. Conditions are aimed to secure greater economy and should bring about lower rates. You can no more prevent consolidation in the interest of economy than you can make water run uphill. The right way to do is to let the railroads consolidate or merge all they can in the interest of economy.

Idaho, Washington and Oregon—Weather favorable for harvesting, which will be under way. Prospects good for an average crop.

ASKS ASSEMBLY TO WAIT. Something Doing Apparently in Great Western Sale.

The Great Western will apparently make no further extensions or improvements until the negotiations now under way for its sale are concluded. A petition for permission to lay a score or more of spur tracks in various places in West St. Paul, so as to make the adjoining land desirable and accessible factory sites, was yesterday laid over by the committee on streets of the assembly, it was said, at the request of the Great Western.

The Great Western has always been most progressive in building up industries along its lines, and had plans for considerable extension of spur tracks on the West side. The temporary deferring of these plans is looked upon by St. Paul railway men as an indication that the negotiations for the purchase of the road by other railroad interests are approaching a fruitful termination.

COAL AND LUMBER RATES. Commission Will Today Have Final Hearing on Tariffs.

The state railroad and warehouse commission will today hold a final hearing on coal and lumber rates in Minnesota and will pass upon the tariffs prepared by the railroads in accordance with the reduction of 15 per cent in lumber rates, and 10 per cent in coal rates, ordered by the commission June 26.

The reduction was ordered after a

thorough investigation of the subject extending over several weeks, and the railroads finally agreed to the reduction. When the work of checking in the incident began it was found that the territory affected, especially of lines operating in Southern Minnesota, was much greater than at first anticipated and at first it looked as if the entire matter might have to be threshed over again.
