

TESTIMONY AGAINST WOOD RULED OUT

Practically Everything Witnesses Say to the General's Discredit in the Investigation by the Senate Military Committee Is Excluded—This Even Includes Evidence Supported by Documents on File in War Department.

WASHINGTON, D. C., Nov. 21.—The senate military committee today continued its investigations of the charges made against Gen. Leonard Wood, Maj. Rathbone, who filed many of the charges, was the first witness. He was asked if he had given out statements concerning the committee's inquiry and admitted that he had done so. He was requested in the future to consider whatever took place inside the committee room to be executive and agreed to refrain from making public any of the subsequent proceedings.

It is believed that this evidence will go before the senate in executive session, and in the event of a decision by the committee favorable to Gen. Wood, the fight will be transferred to the floor of the senate. In fact, notice of this has been given to a member of the committee by one of the senators who joined in the protest against Gen. Wood's confirmation to be a major general.

DECLARES HE WAS FORCED TO "DIVVY"

Former Deputy Revenue Collector Says He Had to Split Up His Salary.

DUBUQUE, Iowa, Nov. 21.—Former Deputy Internal Revenue Collector Milton Howe, of this district, has filed an affidavit with the department charging Collector J. U. Sammis with having compelled him when deputy to share his salary with the collector's brother, an under deputy, contrary to the statutes.

MURDER IS OUT AFTER SEVENTEEN YEARS

Mother of Dead Man. Receives Letter From One Who Had His Conscience Smitten.

SPRINGFIELD, Ill., Nov. 21.—Relatives of F. J. Kilbuck, who died in his city in 1886, in a hospital, say that they have evidence that the man was murdered, and the case is now being opened up. The mother of the dead man has received a letter from an anonymous writer inclosing money and stating that his conscience hurts him.

LAWYERS TALK JUROR TO INSANITY AND SUICIDE


Ex-Senator Vilas and Another Attorney Filled Bornquist's Mind With More Than It Could Hold.

LA CROSSE, Wis., Nov. 21.—By statements of his wife and other information on the days just before the suicide of Carl Bornquist, at Madison, it developed that the juror and tailor's helper was practically talked to insanity and suicide by ex-Senator W. F. Vilas and John M. Olin, attorneys in the case. During the arguments of the attorneys, which consumed two weeks, great volumes of figures and printed matter were submitted. Bornquist thought he must remember it all


to be able to make his decision. His wife says he grew thinner as the days passed and then disappeared. His dead body was found in the river. It is the confident theory of all who know the case that the man was talked to distraction. The case was against an insurance company. After the suicide of Bornquist, Attorneys Olin and Vilas argued for another week as to whether the case should continue with eleven jurors or a new trial should be granted. The case is still being argued.



M'GHEE TAKES TONY CALDERONE TO JAIL

Battalia Murder Suspect Lives in Boarding House in St. Anthony Avenue for Two Days--Is Taken to Minneapolis and Delivered to Sheriff in Dramatic Manner by Attorney McGhee and Dr. Turner, Who Have Cared for the Man--He Is Stabbed Seven Times--Mystery Still Hangs Over Tragedy of the Franklin Avenue Bridge.

Tony Calderone, suspect in the Battalia killing, weakened by many stab wounds, is a voluntary prisoner in the Hennepin county jail. He was delivered to the sheriff early last evening by Attorney F. L. McGhee and Dr. V. D. Turner, of St. Paul. Since Thursday morning Calderone has been in the care of Dr. Turner, lying in a boarding house kept by Mrs. Charles Davis, a colored woman, at 462 St. Anthony avenue.

At 7:45 last evening a hack was driven rapidly up to the south entrance to the Hennepin county court house, two colored men got out and helped a shivering white man swathed in bandages to the walk. The white man was helpless in the hands of the others, but, after looking furtively about, he staggered up the steps of the entrance and permitted himself to be led into the office of Sheriff Dreger. He sank into a chair with a sigh of relief.

To the detectives and sheriffs he declared to talk and the mystery surrounding the killing of Battalia will only be dispelled when the prisoner, or Frederick L. McGhee, his attorney, breaks the silence they have obligated themselves to.

ENGLISH IMMIGRANTS ARE IN A BAD WAY

Food Supply Is Giving Out at Lloydminster, N. W. T.

BOSTON, Mass., Nov. 21.—Advices received here from Lloydminster, N. W. T., declare that the Barr colony, composed of 130 immigrants from London and its environs, is in danger of serious disaster because of lack of food. Lloydminster is 195 miles from a railroad station, and there is every prospect of traffic interruption by snow. There is not in Lloydminster two weeks' supply of any staple necessary of life. The 130 immigrants are mostly in fifty-five tents.

CINCINNATI, Ohio, Nov. 21.—Unable to determine which was his prisoner, Deputy Sheriff Langum, of Minneapolis, who came from Minnesota for Howard H. Sears on a forgery charge, left today with two prisoners. He took along Harry S. Sears, brother of Howard. A telegram was received by Inspector Crawford asking that Howard

H. Sears, aged thirty-two, be taken into custody. The telegram also mentioned Harry Sears and said Howard was the elder and taller of the two men. The men were in custody for beating a hotel man when the Minnesota officer arrived. The taller brother said he was Harry and the shorter said he was Howard. FOOD STANDARDS ARE PROCLAIMED

National Commission Indorses the Bill Introduced by Senator McCumber.

WASHINGTON, D. C., Nov. 21.—Secretary Wilson today approved and proclaimed the official food standards which have just been formulated by the United States food standard commission and the executive commission of the National Association of Pure Food Commissioners. The committee of the latter organization, which met here today, has recommended to the government food standards commission that these standards be adopted. The recommendation states the adoption of these standards will unify the food control work of the states. This committee authorizes its secretary, R. M. Allen, to call an international pure food congress at the St. Louis exposition and to visit at once the governments of Europe and invite them to take part.

EXPLOSION IS DEATH OF MINERS

Ten Are Killed and Five Others Will Probably Die of Their Injuries.

CONNELLSVILLE, Pa., Nov. 21.—"Hill Farm mine," the ill-fated, tonight added ten more victims to its black record. Just as the day shift had about completed its labors and were about to leave the Ferguson mine a terrific explosion rent the interior of the mine, and nineteen miners who were working in the vicinity were thrown in all directions, the roof came tumbling down and the close air of the mine became stupefying.

ITALY RESENTS THE POPE'S SECLUSION

Reprisals Follow the Elevation of Cardinal Merry del Val.

ROME, Nov. 21.—The temporary dis-appointment caused all over Italy by the fact that so far the new pope has not yet broken the line of policy followed by his two immediate predecessors and has remained within the limits of the Vatican has brought about reprisals on the part of the Italian government. The appointment of Cardinal del Val as secretary of state has accentuated the hostility of the civil against the ecclesiastical power, not only because of his foreign birth, but principally by reason of his well known opposition to any scheme of conciliation with the invaders of the papal dominions. He is considered an enemy of Italy, and his recent promotion as prefect of apostolic palaces, which gives him practical control of the Vatican finances, has served only to increase the ranks of the opposition.
