

AGREE UPON A PLAN OF CAMPAIGN IN NEW YORK

Democratic State Committee Will Have Full Charge of Operations in the State and the National Committee Will Not Interfere—National Headquarters Are Opened in New York City—Judge Parker Returns From His Outing

NEW YORK, Aug. 15.—At a conference between Chairman Cord Meyer, of the New York Democratic state committee, and Delancey Nicoll, vice chairman of the national committee today, an understanding was reached regarding the New York state campaign. It was decided that the national committee would not interfere with the state committee in the state, and neither the national nor the state committee will take up any work in New York city and Brooklyn where the campaign will be conducted by the regular Democratic organization.

Parker Constitution Club Formed NEW YORK, Aug. 15.—The Parker Constitution club, composed of members of the bar of New York city, has been formed here with these officers: President, James C. Carter; vice presidents, Wheeler H. Peckham, John E. Parsons, Joseph Larocque and John G. Carlisle; secretary, William Church Osborn; treasurer, William E. Curtis; executive committee, William B. Hornblower, Francis Linde Stetson, John Milburn, Howard Taylor and James W. Gerard.

The statement also criticizes President Roosevelt, saying that he has "set up a policy of autocratic force and has shown that a president who has the will to usurp legislative functions, to exalt the power of the executive above the constitution, and commit our nation to violations of international justice, easily finds a way."

Without interfering with, but rather supplementing the work of the state committee, Parker's many personal and legal friends throughout the state will begin their campaign efforts for him immediately without waiting for the state convention, which is more than a month away.

ATTEMPT TO KIDNAP ACCUSE A DEAD MAN

Trouble Over Young Jewess Gives Rise to a Riot

SEIDLITZ, Russian Poland, Aug. 15.—The anti-Jewish riots reported to have taken place in the Parnochow district of Vlodava on July 30, turn out to be nothing more than a disturbance caused by the Hebrews trying to kidnap a Jewess who had been christened by a Roman priest at Lublin. The local police were able to rescue the convert and disperse the crowd without resorting to extreme measures. About a score of persons were slightly mauled in the scuffle which ensued, but no one was killed or even severely injured.

ACCUSE A DEAD MAN

Dubuque Woman and Others Charge Wrongdoing

CHICAGO, Aug. 15.—A bill in which a dead man is charged with having misappropriated \$125,000 of the funds of an estate was filed today in the United States circuit court. The action was brought by Anna Odell, of Dubuque, Iowa, and John and Samuel O'Dell, of Shelby, Mich., and is directed against the Chicago heirs of the late John R. Wilson.

NEW YORK ROBBERS GET AWAY WITH JEWELS

Owners Will Be Satisfied With the Return of the Stolen Property

NEW YORK, Aug. 15.—Detectives are working on another big jewelry robbery, according to circulars received today by jewelers, pawnbrokers and money lenders in New York and other large cities. The value of the missing articles is not nearly so great as in the Golet case, which the detectives recently reported "cleared up" by the discovery that the jewels had been mislaid and not stolen.

GOVERNMENT ISSUES WARNING TO FAIR

Federal Commissioner T. H. Carter Talks of Conditions in St. Louis

Thomas H. Carter, of Montana, who was in St. Paul yesterday on his way to Chicago and St. Louis, says that ineffective advertising has had much to do with the light attendance at the St. Louis fair.

Former Senator Carter is chairman of the United States commission, and recently sent an official warning to the management of the fair that unless better results were obtained and some indication given that the government would recover some part of its loan of \$4,500,000 to the fair, his commission would consider it the part of duty to take charge of the box office receipts.

The trouble seems to have been that the fair was not properly advertised. While the public had a wide general knowledge of the fair and its manifold attractions, there was lacking that specific information that people want before they will spend their money in travel and sightseeing.

The government has a most decided interest in the financial success of the fair. It has spent enough money to give it a right to make suggestions to the commission, and to see that the largest possible number of people profit by seeing it and its features.

"We are, therefore, interested in seeing that the management obtains the best results possible, and if any suggestions that the commission has made have resulted in increasing the attendance and swelling the proceeds of the fair, we are pleased indeed to have made them."

Commissioner Carter left last night for Chicago and will go from there to St. Louis. He plans to spend the next week or ten days at the fair, looking after matters in connection with the commission.

Speaking of political conditions in Montana, he expressed the belief that his party will carry that state this year, basing his hope on the supposed personal popularity of Roosevelt in western states. He has also faith that his party will control the next legislature of Montana, and admitted that in that event there might be something in the line of a United States senatorship coming his way.

STOMACH HAS CARPET TACKS AND CARTRIDGES

UNCERTAINTY AS TO ATTACHES

ST. PETERSBURG, Aug. 15.—The admiralty has no information as to whether Lieut. Newton A. McCully, of the United States navy, and Lieut. de Cuverville, of the French navy, the only two naval attaches at Port Arthur, when it left the port Wednesday morning last. Had they joined the squadron they would presumably have been on board the flagship Czarvitch.

IN FEAR OF ASYLUM WOMAN TRIES SUICIDE

Mrs. C. Benard Twice Attempts to End Life in Sanitarium

Fearing that she would be sent to the Rochester insane asylum, Mrs. C. Benard, 451 Virginia avenue, twice attempted to end her life while a patient at Dr. A. H. Doty's sanitarium, 449 Wheeler avenue. Mrs. Benard, who has a brother at the Rochester institution, worried to such an extent about him that her mind was affected and she became physically ill. She was placed in Dr. Doty's care three weeks ago.

Dr. Doty says that Mrs. Benard became hysterical after being at his sanitarium a short while. It was explained to him that she had been ill with typhoid fever and that her mind became affected after her recovery, because she imagined that she was to be taken to the hospital in which her brother was confined.

The woman again tried to commit suicide Saturday morning by taking chloroform and iodine which she procured in Dr. Doty's laboratory at night. She was discovered unconscious about 7 o'clock, and Dr. Doty worked upon her until 12 o'clock before she was fully restored. The after effects of the chloroform were serious.

DETERMINES ORDER OF SUCCESSION TO THRONE

Michael Will Be Regent If Czar Dies Before His Son Is of Age

ST. PETERSBURG, Aug. 15.—Emperor Nicholas has issued a manifesto determining the order of succession to the throne. In the event of the emperor dying before the czarvitch attains his majority the emperor's brother, Grand Duke Michael, is to become regent, the empress assuming the guardianship of the czarvitch.

GARDNER DEFEATS JIM JEFFORDS

Knocks Californian Out in Third Round and Injures Him Badly

BUTTE, Mont., Aug. 15.—George Gardner tonight defeated Jim Jeffords in the third round, knocking him out with a right swing to the jaw that laid the flesh open and sent the Californian reeling and spinning to the floor.

STORMING OF PORT ARTHUR GOES ON

EVEN RUSSIANS EXPECT EARLY FALL OF CITY

Land Attack Has Been Going On for Several Days—Japanese Take Heights of Taku With the Bayonet—They Occupy Nearly All the Hills Commanding the Town—Commander of the Defeated Vladivostok Squadron Is Nearing Death

CHIFU, Aug. 15.—The Japanese land attack on Port Arthur has been going forward for several days. The heights of Taku, from which temporary retirement had been made, were stormed and taken with the bayonet. These hills command the eastern bastions. Shaku mountain and Yeauchang have also been captured, and the western side range of hills overlooking the west port is in the hands of the Japanese artillery.

Terrific pounding has gone on for a week. Assaults in force have yet to come. Japanese reinforcements arrive constantly. Each unit hands its guns to the artillery command on Wolf hill, where hundreds of guns are massed. From that direction will come the main assault through the river valleys.

SPECIAL CABLE TO THE GLOBE

SHANIKWAN, Aug. 15.—The storming of Port Arthur is now in progress. The fighting can be seen plainly now from the easterly side of the Liaotung gulf. The Japanese not only have withdrawn their patrol boats, but permit regular traffic between this point and their base, Pigeon bay. They are now obtaining food supplies daily from Shanikwan and Chinese vessels are also carrying them large supplies of lumber. One of these boats in tonight says a great battle is under way for the possession of the southerly end of the Etze range of hills west of Port Arthur properly.

RUSSIANS ABANDON HOPE

ST. PETERSBURG, Aug. 15.—The expectation here is that Port Arthur will fall at any moment. Especial significance is attracted to the fact that Lieut. Gen. Stoesel's wife and children went to Chifu on board the torpedo boat destroyer Ryeshitelni.

RETIRE FURTHER NORTH

BERLIN, Aug. 16.—A dispatch to the Lokal Anzeiger from Liau-yang indicates a belief in the retirement further north of the Russian army. The dispatch says that the Russo-Chinese bank at Liau-yang is preparing to remove to Tialingsien, and that the bank at Mukden is apparently about to close.

The authorities have heard that 1,200 Chinese bandits are preparing to sack Liau-yang as soon as it is evacuated by the Russians. The heavy rains have converted the country into a swamp.

ADMIRAL BEZEOBRAFF DYING

ST. PETERSBURG, Aug. 15.—It is reported that Viceroy Alexieff has left Mukden hurriedly for Vladivostok on receipt of news that the illness of Vice Admiral Bezeobraff had taken a serious turn and that the admiral was not expected to recover.

STILL ANOTHER CRUISER SUNK

TOKYO, Aug. 16.—Admiral Togo reports that a vessel of the type of the protected cruiser Pallada was torpedoed and sunk in the engagement of Aug. 10.

BESIEGED ARE DOWNHEARTED

CHIFU, Aug. 15.—Junks which arrived here today, having left Port Arthur Aug. 12, brought reports that the Japanese occupied new positions on that day. The firing was heavy but intermittent and indicated that the assaults were being continued. The Russians at Port Arthur are reported to be downhearted. The men who came on the junks declare that the commander of the Japanese fleet before Port Arthur informed the Russian commander of the place that if the warships which returned to the harbor after the sortie of Aug. 10 were sunk by the Russians the Japanese would shell the town with lyddite.

A Chinese who has returned arrived here from Liau-yang and declares that the casualties in the recent fighting in that vicinity have been enormous on both sides.

RUSSIA RAISES THE WIND

LONDON, Aug. 16.—The Moscow correspondent of the Standard says that Russia has arranged a new loan with France of \$50,000,000 at 5 per cent, payable in six years, the issue price to be 99 3-4.

NOVIK REPORTED SUNK

CHIFU, Aug. 15.—An unconfirmed report which reached here from Tsing Tau, says the Russian cruiser Novik, which put into Tsing Tau after the battle of Aug. 10, off Port Arthur, and which coaled there and put to sea within her twenty-four hours' limit, has been sunk forty miles from Tsing Tau.
