## MINNEAPOLIS NEWS

### STREETS CLEARED OF THE DEBRIS

Minneapolis Thoroughfares Are Being Put in a Presentable Condition

The work of clearing away the debris along the residence streets of Minneapolis is progressing, and every effort is being made to save the uprooted trees which have not been entirely demolished by the storm. Along Park avenue a great deal of work has been done in this direction, and one forester has already replaced fifty trees which were not damaged other than being thrown prostrate.

Whenever a tree has any chance for life it is pulled back into place, and the top and branches lopped off until it resembles a log set upright rather than a tree. The forester's surgery is heroic, but the experts say it saves the patient.

Many trees are still prostrate, but the roots have been watered and protected from the rays of the sun.

Some of the trees which have been uprooted or destroyed were planted by the owners of the property many years ago, and they take great pride in being able to save them.

A few streets are still impassable, although the street commissioners have had large gangs of men at work clearing away the refuse.

Hundreds of handsome trees which adorned the lawns of modest dwellings will serve to prepare the family dinner, for hundreds of the giants which were thrown down have been manufactured into cordwood for the benefit of the householder.

Telephone companies are busy repairing the damage and hope to have all interrupted service resumed within two days.

Contractors and builders are rushed.

### SALOON MEN FINED

Nine Liquor Sellers Prosecuted for Sunday Opening

Nine saloonkeepers appeared before Judge Holt yesterday and pleaded guilty to keeping their places open on Sunday. Judge Holt imposed the minimum sentence, saying it was notorious that all the saloons of the city were open on Sunday with the knowledge of the police and administration, and therefore he imposed the smallest penalty, but let it be understood that his leniency in these cases was no indication what his future course would be.

The arrests were made upon complaint of the Home Protective League, an organization which proposes to stamp out wine rooms in the city, and the men were prosecuted under the Sunday closing ordinance because of the ease with which convictions could be secured.

The league proposes to keep up the work and the Retail Liquor Dealers association intends to do some fighting on its own account.

Will Also Try the Plan of Manufacturing Brick at the City Workhouse

The board of charities and corrections will ask for \$35,000 for the purpose of establishing a hospital for incurables, persons who do not properly belong to the poor farm, the city hospital and the asylums. In addition it has been decided to complete the administration building at an expense of \$54,000. The total amount asked for the department is \$115,675.

The board will try to establish a \$15,000 brick plant at the workhouse.

## BRIDGE IS HER ROOF

### Mrs. Lena Peterson and Four Children Found Destitute

George McDavid, the negro who was shot last Saturday night, is improving and the report from the city hospital is that he probably will recover.

For the last five nights Mrs. Lena Peterson and her four children have been making their home on the river bank under the Franklin avenue bridge, while Anton Peterson, her husband and father, has been loafing about saloons in a state of intoxication.

Peterson is an expert painter and decorator.

Mrs. Peterson has been supporting the family and living in a miserable home on Cedar avenue. The rent wasn't paid and then came the ejection, and since then the poor woman has been making her home under the bridge.

The Humane society had its attention called to the matter and a warrant was issued for Peterson's arrest on the charge of non-support. He was released on probation by Judge Holt, with the understanding he would take care of his family. Peterson is capable of earning good wages.

### ABSENT DAUGHTER MAKES CALL FOR CASH

S. Danielson, of Bird Island, Tires of Answering Pleas for Help

S. Danielson, of Bird Island, is in Minneapolis searching for his daughter, who left home sometime ago and later informed her father she had married and gone to Omaha to live. Some weeks later she wrote her parent for financial assistance and it was given. Next she was heard from in Minneapolis and another request was made for funds and Mr. Danielson came to the city to investigate. He cannot find any trace of his daughter or her husband.

### VICTIM OF CYCLONE IS STILL UNCONSCIOUS

Condition of August Moy Injured at Waconia Is Precarious

August Moy, the young boy injured during the storm at Waconia, who was brought to Minneapolis Sunday, is still unconscious at St. Barnabas hospital. Yesterday an operation was performed upon his head with the hope that his condition would be improved, but up to the present there has been no change and his condition is precarious in the extreme.

### Mill Slightly Scorched

Defective electric wires started a fire in the dust room on the roof of the Pillsbury mill located near the falls, and the firemen had some difficulty in extinguishing it, owing to the height of the building. The damage, which was largely a water damage, will not exceed \$2,000.

### Burglars Dig Holes

Minneapolis burglars have adopted new tactics. When they find a window or door is securely locked and cannot be forced, they dig through the wall. They did this at M. Rosenstein's store at 313 Nicollet avenue and carried away a quantity of fur garments.

### Protest Killing of Beef by Rabbits

NEW YORK, Aug. 23.—A committee from the local union of kosher beef killers called on the kosher killers who were at work today to protest against their killing of the least and to endeavor to get them to leave the slaughterhouses.

Business Agent Wellman, of the local union, said that if the rabbis refused to leave their work the matter would be taken before the Hebrew congregations at the meeting next Saturday.

Representatives of Schwarzschild & Sulzberger said tonight that the firm had killed about half the number of cattle they usually kill when working their full complement of men.

### Paraguayans and Rebels in Fight

BUENOS AIRES, Aug. 23.—An artillery engagement has been fought between the San Jacinto battery of the Paraguayan army and a body of revolutionaries in which the latter succeeded in dislodging the guns of the government force. The losses on either side are not stated.

There has been no bombardment of Asuncion, the capital of Paraguay, since last reports. The insurgents have established a provisional government with the capital at Villa del Pilar, 113 miles from Asuncion, and have nominated Gen. Ferrera, their leader, for president, and Gonzales Novero for vice president. Four secretaries also have been named. One of these, Deputy Soler, has started for Rio Janeiro and other capitals to endeavor to secure the recognition of the revolutionists as legitimate by the various governments.

This is taken to indicate that rapid operations by the insurgents have been impeded through the non-attendance of the capital owing to the intervention of the diplomatic corps at Asuncion.

Despair is felt in the capital over the failure of the revolutionists for a settlement of the difficulties. All matters have been suspended and articles of prime necessity are hardly obtainable at a famine price.

The arrival of the Argentine gunboat, which was dispatched last week for the scene of the trouble, has not been reported, and a torpedo boat destroyer has been sent in search of the missing vessel.

### Bandits Capture a Banker


