CROWDS CHEER FOR GOVERNOR JOHNSON

THREE THOUSAND WOMEN CAST VOTES

St. Paul saw the result of the election in large part from the street. As soon as the first returns were received the residents of the city gathered in the places advertised and with the first of the reports flashed up on the stereoscopic sheets the crowd grew solid before them as far as the figures could be seen.

The service furnished by The Globe was the most popular in town and the people filled Fifth street nearly to St. Peter and more than half way to Cedar street, and on Wabasha as far back as it was possible for the crowds to see the big sheet stretched on the old postoffice.

The first few reports from the East showing the tremendous vote of New York for Roosevelt were received with surprise and as the crowds were largely in sympathy with the complexion of the report they were received with acclaim.

Crowds Cheer Johnson

The majority of the people who stood in the streets to hear the news of the election were interested more in the gubernatorial fight in Minnesota than they were in the national election and greeted reports from this state with more applause than they did the heads of the national ticket.

In Fourth street the afternoon papers had large audiences and in the Commercial club special effort was made to keep its membership informed of the way the election was going. The parlors of the club were filled with chairs and every one of them was reserved for some woman—the wife, daughter, sister or niece of some member of the organization. The halls and lobby of the club were occupied by the male visitors. It was estimated that the attendance during the evening was well up to 1,500.

Dunn Crowd at Ryan

On the Sixth street side of the Ryan hotel there was another bulletin sheet. There was a large crowd about this stand also and the complexion of it was undeniably Dunn. The returns from St. Louis and Freeborn counties and the Tenth ward of St. Paul caused considerable applause, but when Stearns county was reported the crowd faded away.

The crowds showed the greatest good nature, and while the disappointment of the Dunn advocates was apparent they manifested the same equanimity that the Democrats did with the sweep of President Roosevelt.

There was a disorder even in the thickest of it and when the election of Roosevelt seemed certain and the choice of the state of Minnesota for chief executive of the state had apparently fallen on Johnson the people left the bulletin boards and went home.

JOHNSON AND DUNN RECEIVE RETURNS

Former Says He Feels Finer Than a Fiddle and Latter Is in Fine Fettle

It was the lull after the storm. Yesterday was one of quiet at both the Democratic and Republican state headquarters. L. A. Rosing, after making a hurried trip to Cannon Falls, his home town, returned at noon and again at Democratic state headquarters. Chairman F. A. Day came in from Fairmont late in the afternoon and immediately took the receiver of the telephone line and placed himself in communication with the county chairman.

John A. Johnson returned from St. Peter, where he had gone Monday night after his series of meetings in Minneapolis, and spent the evening at headquarters hearing the news.

"I am feeling finer than a fiddle," the Democratic candidate said in response to an inquiry. "The fight has been wearing, but I never felt better in my life than I do at the close of the campaign. I have made the best campaign of which I am capable, and whether I win or lose, I have nothing to be ashamed of in this campaign. We have conducted a clean, decent campaign, and I have not a word to take back or an apology to make to any living man. My supporters have all been loyal and even more than that. They have taken a personal interest in my campaign far greater than my deserts. I have, in the campaign over the state, made many warm friends and win or lose, would not exchange those friendships for anything in the world. I fail to see wherein my committee has made a single mistake, and the newspaper press, not only of my own party, but of the opposition, has treated me with a consideration no doubt far greater than I could have any reason to expect."

During the afternoon and for the first hour or two after the closing of the polls at 7 o'clock, practically nothing of value was received at either headquarters. Occasionally a telegram came from some county chairman asking for a final estimate of the state, and volunteering information as to his county, but until the votes were at least partially counted the county estimates from the county chairmen were not better than the estimates of anybody else.

Use Voting Machines in Duluth

A report received during the afternoon from Duluth said that the experiment of four voting machines in use at as many precincts in Duluth were proving disastrous for the Democrats. By pulling a lever a Republican or Democrat could vote a straight party ballot. As the voting machines were in strongly Republican precincts, the innovation was a temptation to the Republican to pull the lever, giving him a straight party ballot, including the Republican candidate for governor.

Fred L. Ryan, member of the Democratic state central committee for St. Louis county, telegraphed that the machines were bad for the Democrats. In other Duluth precincts in which there were no voting machines the Democratic committeeman was confident that John A. Johnson was getting a better percentage of the total vote.

R. C. Duran, chairman of the campaign in Minneapolis Monday night, and spent the day of election at his home at Hamline. Reports from him during the day were that he was feeling well in spite of a political campaign which has continued during the greater part of the last year, with only slight intermissions.

Officials Follow Clues in Gebhardt Murder Case

NEW ULM, Minn., Nov. 8.—Corroborative evidence that Dr. L. A. Gebhardt was murdered by the cocaine "fiend" who spent several hours in Dr. George R. Koch's office a few days before the murder, came to light today, when L. Koch, a miller at Fairfax, Minn., telephoned the New Ulm authorities that such a man appeared at Fairfax the day after the tragedy. While in a saloon there he discussed the murder with a man who came in from his place and made several remarks open to suspicion.

The man and his companion came to Fairfax on bicycles from Mr. Nichols. "One of them said he was a dentist, they went into a saloon and ordered a glass of beer and sat down at a table. They picked up a daily paper in which they read an account of Gebhardt's murder. They talked in an undertone and finally one of them said: 'You know the murderer was caught at Le Sueur.' Shortly afterwards they left the place and rode out of town."

From the description given of the man who said he was a dentist, the officers are certain that he is the "fiend" who visited several of the offices, and spent some time in Dr. Koch's office at New Ulm, and who has been under suspicion as the slayer of Dr. Gebhardt.

Both Sides Confident

Both Democratic leaders and Republican managers were confident that the fine day had been a benefit to their candidates. On the theory that a fair day brought out the almost full strength of the farm vote, they were confident that the warm, sunny day was worth 10,000 votes to Mr. Dunn.
