

In the World of Sports ANDERSON OF ST. PAUL HAS HIGH SINGLE SCORE

MILWAUKEE, Wis., Feb. 24.—Chicago lost her grip on one of the national championships in the bowling tournament of the A. B. C. today, when C. M. Anderson of St. Paul, bowled in magnificent form, piled up a score totaling 651 points and overthrowing Otto Kupper of Garden City, whose score of 625 was high at the end of last night's bowling. Anderson bowled a steady game from start to finish and the way he mowed down the set, making strikes and difficult spares, brought forth tremendous applause from his friends and spectators. Several other changes were made in the line-up in the front rank were brought about in today's play. William Ott of La Crosse, and Ed. Schuch, Columbus, whose 608 score was high for two days today, dropped to sixth position. W. F. Frenz of Chicago, 599, who had landed in third place, followed by A. A. Allison of Washington, D. C., whose score of 613 is four points higher than E. Pfeifer of Chicago. The leaders in the two-men division remain in the same position as last night, with Stretch and Rolfe of Chicago, at the top.
