JUDGE HOOKER SUFFERS A RHETORICAL GRILLING

Counsel for the State Bar Association Speaks Harshly of Words

ALBANY, N. Y., April 14.—Justice Warren B. Hooker, whose relations with postal affairs at Dunkirk and Fredonia are the subject of a legislative inquiry, was scathingly arraigned by Frank B. Stevens, one of the counsel of the bar association assisting in the investigation, in his argument before the court today.

"I shall assume," said Mr. Stevens, "that any man who will resort to the worst vices of a ward politician is morally unfit to judge of his fellow men; that any man who will defray the United States government, who is capable of low deceit, conniving, robbing the government of its money, who will instruct the youth of the nation in crime and fraud, is morally unfit to sit on the bench."

Hooker, the judge's nephew, and the other persons appointed to the Fredonia postoffice at the request, it is alleged, of Hooker, Mr. Stevens said: "Mr. Hooker was taught upon the bench of the supreme court in the fraud, what do the teachers and pupils of the normal school see? They see the nephew of a supreme court justice, by illicit means, by wrong means, by means which will not bear the light, get the government funds in his pocket. What is the use of the state maintaining normal schools if they become nothing less than a school for thieves?"

The government at Washington in this case was George W. Beavers. He was the man who passed on the requests of Judge Hooker. They were close intimate friends. On the 14th day of April, 1905, a public officer for a court, thanking every time Hooker made a request of the court, he said: "I have no word to inquire made; absolutely no request raised. Hooker shows a moral unfitness of some kind."

EXPLOSION DAMAGES THE PRESIDENT'S YACHT

Two Men on the Sylph Are Scalded and Signals of Distress Unheeded

NORFOLK, Va., April 14.—The steamship El Cid passed in the Virginia capes today, towing the president's yacht, when the starboard engine had exploded and seriously scalded two members of the crew. The Sylph was at the time of the accident on her way to the regular station at Washington, from Florida waters, where she recently had aboard Mrs. Roosevelt and her children. The Sylph was sighted by the El Cid at sea gave signals of distress, and the liner went to her assistance and towed her into harbor.

The Sylph arrived at the Norfolk navy yard this afternoon in tow of the naval tug Mohawk. The vessel is not badly damaged, but her boilers are disabled as the result of the blowing out of two tubes while the yacht was in a storm in the gulf stream, near Cape Hatteras, Wednesday afternoon. The injured men are T. J. Murphy, machinist, and the steward, who were scalded about the face, arms and hands, and J. J. Dalton, a seaman, scalded about the face and body. Both will recover.

Chief Engineer Evans of the Sylph said that while the yacht was lying at anchor, displaying signals of distress, the United Fruit company's steamer Oterl passed and refused to give assistance. The yacht was compelled to remain at anchor all night until picked up by the El Cid.
