Besides her husband and daughter, Mrs. Robinson is survived by two sisters and five brothers. As they live so far away, none of them except her sister, Mrs. F. E. Zentner, of Joplin and brother, George Brown, of Pittsburg, Kansas, were able to come to the funeral. Mrs. Ava Brown, of Bentonville, Ark., a sister-in-law, is here to attend the funeral.

Mrs. Robinson was a faithful member of the Methodist church, having joined that organization at Richmond, Kansas, in 1896.

PIONEER CITIZEN DIES AT PIERCE CITY

William Buchner Dies After Short Illness.—One of City's Most Honored Citizens.

Wm. Buchner, age about 83 years, died Thursday evening, at his home in Pierce City, after a short illness. Though advanced in years, Mr. Buchner had been hale and hearty all winter. The first of the week he began to suffer with an abscess in his head. At noon Thursday, it was discovered that infection had set in and he died in a few hours.

Funeral services will be held at the home on West Washington avenue, at 2:30 o'clock Sunday afternoon. A number of Monett people will attend the funeral as Mr. Buchner and his excellent family are well known all over southwest Missouri and have many friends here.

Mr. and Mrs. Buchner celebrated their golden wedding anniversary on April 26, 1912. They were married in 1862 at St. Paul's Protestant church in St. Louis by Pastor Will. They remained in St. Louis until 1869 when they moved to Springfield, residing there one year and in 1870 going to Pierce City where they have since made their home.

Besides his wife, Mr. Buchner has three daughters and one son, all living at Pierce City. They are Miss Anna Buchner, Mrs. R. T. Brite, Mrs. Will Roberts and Edward F. Buchner.

Mr. Buchner was one of the pioneer citizens of Pierce City, who contributed to the growth and prosperity of the town. He was a grand old man and his memory will be honored by all who knew him.


