Current Comment.

It will not do for Mr. Wilson and the other Democratic congressional candidates to declare that the gold standard is irrevocably fixed. He and they know that it can be changed by any act of congress, and they know that a majority of the Democrats of the country are just as anxious to change it now as they were when he and they voted with them on that proposition in 1896 and 1900.

"The law's delay" to favored criminals, and particularly hoodlums, should be remedied by the next legislature. There is no more urgent need of reform in any respect than in the proceedings of criminal courts by which continuances can now be obtained by pretense and trial judges deposed from the bench by false affidavits of prejudice. The late postponement of trials of the St. Louis hoodlums Kelley and Gutke was especially aggravating. They had confessed their guilt and had talked freely to newspaper reporters of their purpose to plead guilty and turn state's evidence against the more influential bribers. But evidently they had "been seen," and when their cases were finally called they swore affidavits, that the judge was prejudiced against them. Under the law as it exists, Judge McDonald had no alternative but to send the case to another court, and the delay which the hoodlums desire will be encountered. There should be a radical revision of the criminal code of our state, which will guard the liberty of the individual as jealously as it is guarded now, and at the same time protect the interests of society. It seems to us that the circuit judges should get together and prepare a bill for submission to our next legislature.

A series of meetings are in progress at the Lincoln school house, conducted by Rev. Leonard.

A party of Oregon young people drove through Forest City last Friday, evening, Sept. 23, 1904, while out enjoying a moonlight hayrack ride. As they passed the Atlantic hotel they were egged by a gang of Forest City rowdies skulking in the shadows of the nearby buildings. One girl in the Oregon party was struck in the face by an egg, and all the others were bespattered by the flying missiles. The incident has aroused great indignation here, as the young people from the county seat have many friends among our citizens, and were conducting themselves in a thoroughly proper manner. It was the third attack of the kind made upon pleasure parties here during the past three weeks, and respectable people are determined to secure the punishment of the guilty ones.—Forest City Press.

The cold rains of last week was pleasant music for the duck hunter as he rummaged in the attic for his gum boots, his rain coat and his rubber helmet. As he sat at the kitchen table oiling his gun and filling shells with shot he rejoiced at the coming of the fall rains. It was the eve of the duck season, and better duck weather than was promised by that cold rain could not be imagined by the hunter. The game law's protecting arm was withdrawn Friday night last from the wild birds, which fattened with their feeding in the north, are now preparing for their southern flight. The open season for duck and deer began in Missouri, Saturday last. As far as deer are concerned, there is little to the season in this part of the country, though in the southern part of the state, in the fastnesses of the Ozarks, there are still a number of the timid animals to be found. Deer hunting in the Platte purchase, however, went about the same time that the Indians wended their way to foreign reservations, and the sight of a wild deer would be as much a surprise as the appearance of an elephant or a boar constrictor.

Current Comment.

Under the management of the Democratic party, the right to vote in three great cities of Missouri has been taken away from the people. Restore that right or Missourians will lose their manhood.

George Frisby Hoar, senior United States from Massachusetts, died at his home in Worcester, Mass., Friday last, Sept. 30, 1904. No other senator of Mr. Hoar's standing lived so simply as he. In Washington he did not keep house. Hence, of course, he did no entertaining and took small part in the social life of the capital. His favorite subject was history, and he read it not, as so many did, for the sake of amassing a knowledge of unrelated facts, but in the spirit and with the zest of a philosopher tracing through the stories of the written page the motives of men who have shaped events in all ages, the influence of these events on national character and the logic of the effects which have flowed from divers causes.

Ed. Butler the St. Louis Democratic leader says: "I am a Democrat, a yellow-dog Democrat. The yellower the dog, the stronger is my Democracy. I desire to repeat that. I am supporting the whole Democratic ticket, Mr. Folk and all. Furthermore you may say for me that I have already sent my usual contribution to the campaign fund of the Democratic state committee, and it has been received by them." The chairman of the State committee denies that he has received Boss Butler's contribution, and says that he does not want any of his money, but we are of the opinion that the chairman prevaricates a little. Butler's check is in existence and the Democratic campaign fund collector received it. The Butler-Folk deal is completed, just as was expected.

In the state there are thirty-four senatorial districts, each electing one senator, and 132 representative districts, electing 142 members—in all, 176 members. The representative districts are identical with the counties except that Greene county has two districts; St. Louis county, two; Jasper, three; Buchanan, four; Jackson, six, each electing one representative. The city of St. Louis has six representative districts. The first elects three representatives, the second three; third, three; the fourth, three; the fifth, two; the sixth, two—in all, sixteen. Eighty-nine is a majority of the legislature. The senators are elected, one-half every two years. The odd numbered districts elect this year. The senators serve four years, the representatives two years. Of the seventeen hold-over senators fourteen are Democrats and three Republicans.

The maneuvers of Field Marshal Oyama indicate a purpose to advance on Mukden. The car with which the line of approach has been formed, and especially the extent of its flanking wings, are in contrast with the impetuosity of the advance on Liao Yang. Oyama's deliberations denote at least a willingness that Kurapatkin should withdraw without an engagement, and it is one of the possibilities that the Russian commander may prefer this policy to another great battle. But it seems certain that the Japanese will make another of their ferocious assault if there is no other way to drive the Russians further to the north. Such a battle might easily be even more destructive than that of Liao Yang, for the reason that both armies have received large reinforcements in the interim of comparative inactivity. It seems from later reports that the Japanese after an apparent stop in hostilities, resumed the attack on the Russians before Mukden on Monday of this week and that General Kurapatkin's left wing was forced to retreat. The Russians were taken by surprise and the retreat became a rout.
