THE PAVING DECISION.

The supreme court decision on the local paving assessment case, announced yesterday, which ordered the dismissal of the bill brought by various abutters on Main street against the city of Barre, while it declared the assessment unauthorized because of the irregularity of the mode of procedure, did not touch upon the constitutionality of the section of the city charter which gives the right to levy for one-half the cost on the abutters. That really was the vital point of interest to both the abutters and the city. And since no opinion was expressed on that point, the section of the charter which gives the right to assess for the betterment is to all intents and purposes constitutional, as the city has always contended it was. As the matter now stands the city can continue the work of paving (and everyone admits the necessity of it) from the center of the Miles granite building to Depot Square at least) and assess according to the stipulations of the charter, as it did not do on the part already laid. If, when that shall have been done, the temper of some of the abutters should be to fight the payment then the case would go into court on the constitutionality of the assessment, and the thing would be settled. But it is by no means certain that the payment of one-half the improvement would now be contested by the abutters. The Times believes that all who

are in a position to make comparisons between the present conditions and those that formerly obtained will be free to admit the benefit, and it seems certain that there would be much less disposition to contest the payment than formerly. However, if contest is raised, the city is undoubtedly prepared to meet it. The course to be pursued with respect to the payment of that part of the pavement already laid has as yet not taken shape. That there is a course open is certain. It might be well to state that the city's side of the assessment contention has not yet been presented before the courts. The demurrer presented by the city necessarily conceded the facts in the case to be as the abutters claim.

CAMPAIGN FOR PURE WATER.

State Board of Health Warns Various Vermont Committees.

It is evident from orders sent out by the state board of health to the municipal officers of Burlington, Vergennes, Swanton, Enosburg Falls and St. Johnsbury, which differ only in minor details, according to local conditions existing, that a vigorous campaign has been begun against contaminated water supplies, and that the board means business. The order issued to Swanton is given herewith:

"To the Trustees and Citizens of the Village of Swanton:
 You are hereby notified that the state board of health have examined and have had analyzed at sundry times, various samples of water taken from the village water supply of Swanton, as pumped at the village of Swanton from the Missisquoi river; And that said board of health find and are of the opinion that the water so pumped by the village of Swanton and furnished for domestic use by the village to consumers, is so contaminated, unwholesome, and impure, that the use thereof for domestic purposes endangers the public health.

"And warning is hereby given that unless the quality, purity and wholesomeness of the water so furnished by said village to consumers for domestic purposes, shall on or before the first day of June, 1906, be found by this board of health to be wholesome and pure, free from contamination, so that the use of the water so furnished by the city for domestic purposes shall not endanger the public health, said board of health will, on said first day of June, 1906, under and by virtue of the authority vested in it by section 1, act No. 115 of the Acts of 1904, prohibit any and all persons, and particularly the inhabitants of the village of Swanton, and the officers, servants and employees of said village, and all public institutions in said village, from using for domestic purposes water so furnished by the village of Swanton, and will undertake to enforce such order in manner and form as the law provides.
