John H. Senter made a new declaration of independence for Vermont yesterday.

The Democratic members of the Vermont house have no cause for quailing over Speaker Cheney's appointments. With Porter of Wilmington at the head of the committee on ways and means and Senter of Montpelier as chairman of the committee on corporations, the Democrats secured two of the most important places in the list.

Governor Proctor deftly side-stepped capital punishment in his inaugural message, or was it an oversight? Governor Bell was more outspoken on that subject than he was on others when he said: "During my term of office it became my duty to see that this law was carried into effect. In the general discussion of the subject this occasioned, in the state as well as elsewhere, I have been deeply impressed with the fact that Vermont has more regard for the dignity of the law than for sickly sentimentality. I am more firmly convinced than ever before that, as a safeguard against violence and as a protection to society in general, the law making capital punishment, in some form, the extreme penalty for crime should be retained on our statute books." We do not recollect that Governor Proctor has made any public utterance of his views on the subject.

THE SUMMER HALF-HOLIDAY.

That the workmen in the granite plants of the city have appreciated the Saturday half-holiday during the summer goes without saying, and they appreciated it today in double measure when the regular fall and winter schedule was resumed. During June, July, August and September they were released from labor at the noon hour,

thus giving them opportunity for recreation or whatever appealed to them during the Saturday afternoon. Picnics, sports and the like have largely occupied each half-holiday, and without doubt they were physically better fit for the respite.

CUTTING OFF THE GOLDEN EGG SUPPLY.

It would be suicidal policy on the part of the hotels in Montpelier if, as announced, their rates were so high that the state dairymen's association felt constrained to hold its annual convention in some other Vermont city. Montpelier should be able to give as reasonable rates as Rutland, Burlington, or any other city. Yet it is stated that because of the high charges of the Montpelier bonifaces the dairymen are turning their eyes toward Rutland. That policy is like killing the goose for immediate consumption when the fowl might continue to lay golden eggs for years to come. Here is an opportunity for Montpelier's "committee of safety" to get in its valuable work. Why not let the goose live a little longer and continue to lay those golden eggs? Even the hotel-keepers ought to recognize the short-sightedness of their alleged policy. Once directed in another direction, the stream of conventions and the like will not easily be turned again in the direction of Montpelier. The reputation for greed spreads like wildfire.

RUSHING LEGISLATION.

The old proverb runs that haste makes waste, and so it does in many cases. But the haste of the Vermont legislators in rushing through the bill to require corporations to produce their books in the trial of causes will not result in waste. If any measure was ever "railroaded" through a legislature it was this bill, and much as the process is odious the circumstances seem to have warranted the rush methods this time. Those who attempted to block its passage undoubtedly acted in good faith,

having the conviction that the suspension of rules so that the bill could be read the third time immediately following its introduction is wrong in principle. Under ordinary conditions, their position was right. The circumstances of this case, however, were such as to require prompt action. Here was a corporation which had persistently refused to show its books so that the Chittenden county grand jury could get at the facts of the alleged sale of diseased cattle by the state of Vermont. It is understood that the company did produce some slips which had some bearing on the case, but which, were valueless to the state of Vermont in its investigation. The books of the company were in Boston according to the assertion of the company's officers.

These books were necessary to the prosecution of the investigation it was decided, and their scrutiny before the grand jury was required. Was the state of Vermont to be balked in its efforts to ferret out this scandal? Was it to confess itself defeated by the refusal of a corporation, a child of its own creation? Was it to allow the ends of justice to be thwarted and supinely back down? The Chittenden county grand jury was to meet again within a week, and if the investigation of the diseased cattle matter was to be continued, the books of the particular corporation must be at hand. In view of these facts, haste was warranted, so that the legal weapon for solving into this deal might be placed in the hands of Attorney General Pitts and the state's attorney for Chittenden county at once.

REFUSED CHECK.

Charles E. Hughes Bars Every Contribution of Campaign Money.

New York, Oct. 6.—Candidate Charles E. Hughes has furnished unmistakable evidence of his determination to insist on the enforcement of his wishes that no financial contributions from corporations be accepted. A good sized check, signed and countersigned by the officials of an influential corporation, reached Secretary Gleason of the state committee, with a complimentary note endorsing Mr. Hughes. It was turned over to Chairman Woodruff, who showed it to Mr. Hughes.

"Send it back at once," ordered Mr. Hughes, to the consternation of the "practical" leaders who heard him. The check was returned to the contributor with a polite note of regret. The state committee, acting in accordance with the wishes of Mr. Hughes, has decided to reject all contributions of a like character, but will receive with thanks the offerings of individuals below \$200.

Mr. Hughes was the recipient of many congratulations Thursday on his speech accepting the nomination. There was a great demand for copies of it to be circulated throughout the state. It will be printed in English, German, French and Hebrew for general distribution. Mr. Hughes, with Attorney General Mayer and Lieutenant Governor Bruce made his first public appearance of the campaign last night at Carnegie hall, where the local Republican organization will ratify the ticket.

Arrangements are being made for his introduction to voters up the state next week. The work of drilling the army of spellbinders began yesterday, and they will be turned loose on the public in all parts of the state Monday.

IMMIGRANT MOTHER'S FLIGHT.

Temporarily Lost on Way to Kansas to Find Her Son.

Writing of Ellis Island scenes in "The Men Who Are to Vote," in the October Everybody's, Ernest Poole says:

"In this same hall an old Austrian mother was kept five days. She had lost the railroad ticket her son had sent her. Again and again they telegraphed to the small town where she said he lived, but no reply came. 'He is so fine, so strong, so rich—my Fritz!' she kept saying. 'This fine dress and this bonnet he sent me. To Austria he wrote me every week. Surely—surely he will come!' 'She grew worse and worse. She could not sleep at night, and all day she sat by the window watching the Manhattan sky-scrapers. Her face grew haggard and lined with tears. She was so bewildered, she could no longer answer

questions. The name of the town was all she could give. There were eighteen towns of this name in various states; but the name of her son's state she had forgotten. All she knew was that Fritz lived in a town 'quite near New York' Town after town was telegraphed to. Still no reply. At last it seemed hopeless; and the old lady was about to be deported.

"Suddenly came a telegram: 'Hold mother! An coming!' And four hours later another: 'Don't depart my mother. I have plenty to support her. Am coming by fast train. Hold her!' 'And late that afternoon a young man, sleepless and wild-eyed, arrived—from Kansas! 'Quite near New York!'
