

MAYOR SCHMITZ ON TRIAL

He Faces Extortion Charges in San Francisco

HEARING DELAYED A DAY

Request of Prosecution—Spreckels and Associates Scored by Mayor—Sinitzer Motives in Their Graft Campaign, He Says.

San Francisco, May 21.—Mayor Eugene Schmitz appeared for trial yesterday in Judge Dunne's court on five grand jury charges of extortion from local keepers of French restaurants. By request of the prosecution the hearing was delayed one day in order that counter affidavits may be prepared against Schmitz's motion for a change of trial judge.

District Attorney Langdon was Saturday night served by Mayor Schmitz's attorneys, Metson, Campbell and Deew and John J. Bartlett and C. H. Fairall, with notices of motion of substitution of trial judge on the grand jury. Judge Dunne is disqualified by bias and prejudice.

Accompanying and supporting the motion is a lengthy affidavit by Schmitz in which charges are made against Rudolph Spreckels, his associate in the bribery graft prosecution, and Judge Dunne himself. Schmitz is charged jointly with Abraham Ruef with extorting money from French restaurateurs. Ruef last week pleaded guilty.

Among Schmitz's allegations are the following: That Mr. Spreckels and the associates who are with him, the financial guarantors of the bribery graft investigation and prosecution, long since exhausted the original fund of \$100,000 pledged by Spreckels and have expended nearly one million dollars in a municipal purification campaign; that the expenditure of this vast sum of money is by way of an investment from which actual monetary returns are expected; that Spreckels and his associates, desiring and purposing to overthrow the present municipal administration in order that they themselves may assume the reins of government and procure for themselves street railway and water franchises which will net them millions of dollars of the public money; that Judge Dunne is aware of this intent and purpose and is therein with in accord; that the conviction of Schmitz is desired as a means to these ends, and that it is the wish of Judge Dunne that a biased and prejudicial jury

be selected to procure such conviction; that for that and various other reasons, the same as set forth recently by Abraham Ruef in his application for a substitute trial judge, it is impossible for Schmitz to have a fair and impartial trial at Judge Dunne's hands.

The committee of seven, to which Mayor Schmitz has given full power to cope with the peculiar situation brought about in municipal affairs by the development in the graft campaign, will meet tomorrow. An invitation has been extended to a number of labor leaders to be present, with suggestions. The committee has issued a declaration of principles, in which it says: "We intend to bring about a clean condition of affairs in this community, and make it safe for habitation by human beings and for the investment of capital. We shall do nothing in the nature of class legislation, and recognize that every element in the community has a right to representation in the government of the city."

FRISCO'S GRAND JURY IS NEAR END OF GRAFT WORK.

This Week Will Conclude Inquiry Concerning Big Bribery Cases.

San Francisco, May 21.—This week, it is said, will witness the close of the grand jury's "graft" investigation, except for the picking up of later loose ends of testimony concerning the minor corruption deals, and examination into the affairs of the municipal departments. A new batch of indictments, it is expected, will be voted within the next few days. District Attorney Langdon said:

"The grand jury's work is practically at an end, and so far as the investigation of the matters which we have undertaken is concerned should be concluded by the end of the week. Certain matters must still be inquired into, but the evidence against all those men connected with the big bribes is about concluded."

HIS OWN JAILOR.

Abe Hummel Starts For Prison Without an Escort.

New York, May 21.—Abraham H. Hummel, who for nearly a third of a century was one of the most widely known criminal lawyers in this city, yesterday began the service of a one year's sentence in the Blackwell's Island penitentiary.

The sentence was imposed upon a conviction two years ago for conspiracy growing out of Hummel's connection with the Dodge-Morse divorce litigation. Hummel fought the conviction through several courts, but the final decision was adverse to him and it was decreed that his term of imprisonment should begin today.

Hummel started for the penitentiary from his home in East 73rd street in an automobile and without a guard. He had been at liberty on bail and had given his promise that he would go voluntarily to the prison today.

A big crowd was gathered in front of the Hummel residence, when the little lawyer dashed out of a basement door, holding a large handkerchief in front of his face. He ran to the curb, jumped into the closed automobile and a moment later was whirled away toward prison.

The automobile carrying Hummel did not go direct to the Blackwell Island landing, and for hours after it sped away from the house no trace of it could be found. At 2:17 o'clock this afternoon the officials of the penitentiary were still awaiting the arrival of the prospective prisoner.

IN FOOT BALL WEATHER

James Proved an Easy Mark and Will While Clemens, Who Relieved Him, Pitched a Good Game of Ball.

In a close and exciting game, characterized by heavy hitting, Barre-Montpelier defeated Concord in the New Hampshire league yesterday afternoon by the score of 7 to 6. The locals turned the trick in fine style in the last half of the ninth with the score tied. After zigzagging back and forth the score stood 6 to 6 at the last of the seventh. Neither side scored in the eighth and the visitors were unable to tally in their half of the ninth, but with the head of the batting list up for the locals, Jennings walked up and rapped out a sharp single by third base. Monahan sacrificed him nicely to second and Capt. Harris then sent a clean single into right center, making his fourth safe hit, scoring Jennings and the game was won. The crowd of 200 fans who shivered and stamped for two hours in the cold felt well paid for their shivers.

It was a cold, raw wind for pitchers to work in and the bright sun made several fielding errors excusable. James made his initial appearance in the box for the locals and was hit hard besides being wild. In the sixth inning he was replaced by Clemens, the south-paw, who also made his first appearance and showed up very favorably. He has good speed and lots of twine. The home team kept themselves warm by swatting the ball for sixteen safe hits off Melonis of Concord, but they were not bunched to any great extent, hence the small score.

Concord started out in the first inning by pounding James for a single and a homer for two runs. Fisher rapped out the single and Shea, Concord's big captain, pounded the ball into deep left to the bank of the river for four sacks and bringing in Fisher with him. The home team was not daunted by this and went in in the last half and tied the score. Jennings, getting a free pass, was sacrificed to second by Monahan and scored on Harris' single. After Catter's out Ball scored Harris on a two-bagger to center field.

There was nothing more doing until the fifth, when each team put in one more tally. O'Day rapped out a two-bagger for Concord and scored on Shea's single to left. Ball got a life for the locals on an error by short, went to third on Fraser's single and scored on Rudolph's out to center field. In the sixth the locals got one point ahead. Harris reached first on a single and was forced to second on a base on balls. The new Hampshire league is at present made up of eight teams, two of which are playing in Manchester, N. H., under the names of East and West Manchester. According to Mr. Milne the two teams are more than the city can support and it is the intention of the league officials to send to Rutland one of the teams, that is, if enough interest is manifested among the fans here. This team may or may not be strengthened, which will, of course, rest with the local management.
