This is Seed Year in Vermont and Will Not Come Again for Several Years.

The increased interest in forestry in Vermont and all other parts of the country has created an active demand for seed of the common white pine.

The total registration in the Rutland public schools of this city at present is 1,952, an increase of 32 over last year.
