

Her call for help aroused her husband, and he grabbed his revolver, but did not shoot for fear he would shoot his wife. Mr. Rockefeller lives in a very lonely road, but he has his home well guarded. He is still at Pocantico Hills, and his neighbors think of calling on him and asking for extra police protection.

Army of Idle Appeal to Mayor of St. Louis

THEIR PLEA FOR AID

In Obtaining Work Answered—City Will Do All That Is in Its Power—Procession Led by "Hobo" Philanthropist Eadsnow.  
St. Louis, Jan. 16.—Hungry and out of work, eight hundred men marched through the snow and cold to the city hall Tuesday, seeking Mayor Wells in order to make application for his assistance in securing employment. James Eadsnow, philanthropist and son of a wealthy family, who proudly styles himself a "hobo," led the procession and the Welfare association, of which he is the founder and benefactor, formed the nucleus of the "army." When the start was made from the association headquarters five hundred men were in line, W. J. Millard, a Socialist leader of Cincinnati, acting as marshal. A meal of bread and black coffee was served just before the start, and each man received two slices of bread and a tin cup of coffee. The leaders shouted invitations to men on the sidewalk to join the ranks of the unemployed, and soon the ranks were swelled to eight hundred. All the way the men were orderly. While the hungry hobo lined up in the city hall grounds, a committee representing the "army" waited on Mayor Wells, who assured them that he would do all in his power to give them employment. "I cannot give you charity work," said Mayor Wells; "under present conditions the only thing I can do is to divide the work now being done for the city and give part to you."

The orders Tuesday night voted to go on record in favor of a shorter workday, and to ask Representative Ross to introduce a bill in the legislature for shorter hours for textile operatives.

Steel Plant to Reopen. Pittsburgh, Pa., Jan. 16.—The plant of the Pittsburgh Steel company at Glassport, near here, will resume in full next Monday with a force of 300 men. It has been idle since the Christmas suspension.

Shoe Factory Resumes. Calais, Me., Jan. 16.—The shoe factory of Trimble Brothers in this city has resumed operations after a three weeks' shutdown.

Plan Closed Indefinitely. Newton, N. H., Jan. 16.—The plant of the Newton Box company has been closed for an indefinite period. Lack of orders is given as the reason for the shutdown.

At Point of Gun He Gets \$500 For Calf Which Machine Had Killed. New York, Jan. 16.—Aaron Banks, a Pitt Brook (N. Y.) farmer, lives on a road much frequented by autoists. He has made many unwilling sacrifices to these cars in the shape of dogs, chickens, geese and lambs, so he determined to "get even." He stationed his two sons, in a clump of bushes at the roadside, with a four-week-old calf; across the highway the calf's noisier was tethered to a full view. He told his sons to turn the calf loose at the moment the auto approached. The trap was timed to the fraction of a second; the chauffeur had not time to avoid a collision; the big car lurched the calf in the air; it fell lifeless. Mrs. Metcalf, who shot at Banker John R.
