SECURITIES ARE MISSING

\$400,000 of Them in T. A. McIntyre & Co's Matter

THE RECEIVERS FIND

Many Suits Will Be Started Against the New Firm—The Head of the Firm Ill Since the Death of His Wife.

New York, April 29.—Receivers of the big cotton, stock and grain house of T. A. McIntyre & Co., after a preliminary investigation of its affairs, announced that \$400,000 of securities in which customers of the firm had a substantial interest are missing.

Some of the securities of which there is no record either in the firm's books or in loans with banks, it appears, have been paid for in full and were left with the firm, according to the communications filed with the main office of McIntyre & Co.

"I have here a list of securities, being the assets of the firm," said Charles C. Burlingham, one of the receivers, "but the accountants have not taken the trouble to estimate their value. The list comprises nothing but 'cats and dogs' of the street, securities which the firm could not borrow on."

It Is Not Believed, However, That the Message Will Make Any Change in the Program for Adjournment.

SAYS HEANEY SPENT \$26,000 IN 7 DAYS. Magistrate O'Reilly Acquiesces, However, in Granting Young Man \$150,000.

New York, April 29.—Arthur J. Heaney, one of the heirs of the late wealthy pawnbroker, while in Washington after his father's death spent about \$26,000 in seven days. He almost literally "dropped it."

Magistrate O'Reilly, administrator of the estate of the late Mr. Heaney and his daughter, Mary J. Heaney, who left nearly three quarters of a million in cash, real estate and personal property, said this statement in the Adams street court, Brooklyn, after he had finished the day's business.

Young Heaney, through lawyers, demands \$150,000 from the estate. He is only 21.

"In Mr. Heaney's will," said Magistrate O'Reilly, "it is set forth that the young man who is careless with the money, shall not receive the full share of cash until he is 25. The courts, however, have decreed that, as he has reached the legal age, he is entitled to the money. I guess that settles the matter. But to pay off this cash it probably will be necessary to sell the business."

PAVING MEN NOT SETTLED

Still One Union at Odds in Westerly, R. I.

THEY WANT \$1.50 RAISE

On a Thousand Blocks, While Manufacturers Want Them to Go Back for the Old Bill of Prices—Most of Them Gone.

Westerly, R. I., April 29.—Now that the grievances that have existed between the granite cutters and the manufacturers of Westerly have been settled, a settlement is looked for by the paving cutters, who have been out on a strike for several weeks.

The conditions remain about the same as they did along near the beginning of the trouble. The manufacturers' association demand that the paving cutters work at the old schedule of prices, which have practically been the same for the past six years.

The paving cutters met the association last Saturday and made another offer, it being that they be raised on a sliding scale, at the rate of 50 cents a thousand each year until the end of three years, when they shall receive the \$1.50 increase.

When the strike started there were forty paving cutters at work in Westerly, but today there are but eight in town. The absent number have received employment in other towns.
