As a Woodcock was eating dry grain she had a coughing fit and inhaled a mouthful. She sneezed so badly that it was necessary to kill her.  
Robert Sweeney, aged 12, and Fred Wooster, 16, who recently escaped from the industrial school, were captured at Leicester and returned to that institution Wednesday. This is Sweeney's third flight.  
Edward Willis, colored, of Wallingford, who was struck by the milk train near Wallingford depot last Sunday, died Wednesday night from his injuries, which included a broken back. Mr. Willis was about 63 years old and a barber by trade.

As the result of a monstrous attack by August Hilliard, Edward Roberts of Danby, 90 years old at the point of death. The assailant is said to have knocked the old man down and clubbed him over the head unmercifully. Hilliard has served time at the house of correction.  
Seven frosts were experienced Tuesday night throughout the state. In some places the mercury dropped six degrees below the freezing point. Plum and small fruit trees are in bloom, but it is thought no serious damage was done to the crop. At Swanton Center, ice nearly one-half inch in thickness formed on still water.

John Putnam of West Rutland, an employe of the Rutland Manufacturing company, while engaged in running a rip saw Thursday, received a severe injury to one of his arms. Being in a hurry to get his work started, he released the material in the saw and a board flew back and struck the arm. His arm was badly bruised, but not fractured.  
Tuesday night lightning struck a large barn belonging to Charles Murkland in East Middlebury, burning it with its contents to the ground. The barn contained two mowing machines, one drop reaper, a heavy wagon, and a heavy pair of work horses and small farm implements. The loss will be about \$1000, partly covered with insurance.
