Notwithstanding that Middlebury college conferred the degree of Doctor of Laws on Governor Mead only yesterday, the governor had already doctored the laws of Vermont at the last session of the legislature—else we should have had a few rather poor specimens of laws.

In a half-column editorial, the staid Boston Transcript turns from affairs of

state and complains that the Boston Americans do not give Ray Collins a chance in the pitcher's box. Recovering from our surprise, we say yes, give the fellow a chance; he's got the ability if he gets the chance, for which the contemporary asks.

With this week, Wesleyan university, at Middletown, Conn., passes out of the list of co-educational colleges, fulfilling a long desire on the part of the male contingent of the changing student body. In case the proposed college for young women does not materialize in Connecticut, a great many young women will most likely be deprived of the benefits of higher education, for many are not able, financially, to go outside of the state to attend college. If Wesleyan were a state university, it would not be right to deprive the women of participation in its classes since the state appropriation could scarcely be dispensed for the benefit of one sex, to the detriment of the other. Indeed, it seems that the action of abolishing co-education in Wesleyan itself is a very great handicap on the women of the state.

To show the extent that Barre is creeping up on Rutland in population, it is only necessary to point to the comparative statements of taxable polls. There are in Rutland this year 3,496, which is only 92 larger than Barre's list. It is difficult to reconcile those

comparative figures with the census returns for 1910, when Rutland was shown to have more than three thousand greater population than Barre. Certainly the difference of ninety-two in taxable polls does not represent a difference of three thousand in population. Therefore, in casting about for a reason for the apparent discrepancy one might conclude that a greater percentage of Barre's population is made up of men without families; and that seems to be the case, inasmuch as a large number of workers in the granite industry are single men, many of whom are, too, only temporary residents of the city. In the matter of settled families Rutland considerably outstrips Barre yet.

INVITING NEW-COMERS.

That publicity will result in the taking up of idle land is indicated by the report of the New Hampshire state agricultural board for the past three months. Ex-Governor N. J. Batchelder, who is secretary for the board, announces that the last quarter of the year has been the most busy of any like period since he entered upon the work, there having been transfers of more than one hundred pieces of property, to out of the state parties. In many of the cases the transfer was for the purpose of merely summer resorts, but oftentimes the land is taken up by persons who enter the state with the intention of remaining permanently. But whether the land is taken for summer residence or for all-the-year occupation, it is better than having the land idle, as it would be in most instances. In this work New Hampshire is ahead of Vermont, it must be admitted. However, steps have been taken in this state to catch up with New Hampshire, a publicity bureau having been established and having already started its work with good prospects. If the Vermont bureau shall attain as much success as the New Hampshire board of agriculture has attained, the movement will have vindicated itself surely. If the prospective purchasers of land are seeking land for cultivation, they will be likely to find what they want in Vermont sooner than in New Hampshire, but in the matter of shore resorts, Vermont is less fortunate than its neighbor. There is plenty of idle land for cultivation in Vermont, good land, too, with a little attention.

VERDICT FOR DEFENDANT.

In Case of L. N. Kellogg vs. G. M. Baldwin at Middlebury.

Middlebury, June 22.—The jury in the book account case of L. N. Kellogg vs. G. M. Baldwin yesterday at the opening of the morning session of county court returned a verdict in favor of the defendant that he should

recover the sum of \$47.89, including interest and costs. Another jury case was immediately started, that of How, and Hasseltine vs. Alfred Phelps and is brought to recover the sum of \$150 for alleged false representation, when the plaintiff purchased a horse from the defendant in September, 1910.

The plaintiff claimed that Defendant Phelps warranted the horse to be kind and gentle and such a horse as a woman could drive and that he was also a good work horse in a team. All this the plaintiff claims, he found to be contrary to the facts within a few days after the purchase of the animal, and he at that time tried to induce the defendant to take back the horse and even offered to sacrifice part of the purchase price, but the defendant refused. Murray Bourne of Bristol and M. G. Leary of Burlington are the counsel for the plaintiff and the defense is represented by Jasper G. Page of Bristol and Frank L. Fish of Vergennes.

GANON-HENRY.

Pretty Church Wedding at Richmond Yesterday Morning.

Richmond, June 22.—The Church of Our Lady of the Holy Rosary was the scene of a pretty wedding Wednesday morning when Miss Florence Henry of Bristol was married to James Ganon of this town. They were attended by their fathers. Miss Grace Henry, a sister of the bride, was bridesmaid, and Charter Simonds of Norwood, N. Y., was best man. The Rev. A. P. Clermont performed the ceremony. The bride was gowned in white and carried bride roses, while her bridesmaid wore blue and carried oxeye daisies. The usual wedding marches were played by the Henry orchestra, and a reception was held at the home of the groom after the ceremony.

RUTLAND'S GRAND LIST.

Shows Considerable Increase; Also In Taxable Polls.

Rutland, June 22.—The grand list of Rutland shows for 1911 an increase of \$5,680.21 over that of 1910, according to the report of the board of assessors made yesterday. There is a gain of 279 in polls for the year. The total taxable real estate is \$6,812,030 and the personal property is valued at \$1,806,114. The polls number 3,496. The grand list is \$93,173.44. The tax book shows that Gov. John A. Mead pays taxes here on \$148,165.
