BURNS AGAIN FLAYS GOMPERS

Says Latter Attended Dynamite Jollification Bee

McMANIGAL TO GRAND JURY

Tells of His Part in the Dynamiting Outrages and Implicates Other Men in Structural Iron Workers' Union—Gompers Silent.

The day after the arrest of James B. McNamara, said Detective William J. Burns in this city yesterday, Samuel Gompers came to Indianapolis and sat down with the board that voted the money for McNamara's defense. That board, declared Burns, was called as a jollification meeting over five dynamiting that were to have taken place in Detroit. They did not come out, Burns explained, because the places were too well guarded.

Burns also said James B. McNamara offered \$30,000 to be let off and said he would "get the money in two hours. The American Federation of Labor is back of it."

Both the McNamaras are degenerates, the detective declared, adding that if James B. regained his liberty within twenty years he would go back to dynamiting.

Burns came here from Philadelphia to investigate dynamite explosions in and about New York City. They were all, he declared, the work of the McNamaras and "their gang."

The sleuth said Samuel Gompers was convicting himself out of his own mouth in not denying the charges he was making against him.

"I am not an enemy of organized labor," he continued. "I believe in the great work that it has done for the laboring man, and I speak the truth when I say that such conservative leaders as John Mitchell and others have stood behind me and my work. Organized labor has come to stay, but if unionism is to prevail it must kick out, boots and breeches, the corrupt and dishonest leaders and the corrupt machine which is dragging it down to-day."

The plaintiff's attorney raised the objection that the proctor was in no way connected with the case and that he had no right to interfere. Judge Guthrie sustained the point.

Washington, Dec. 8.—The Payne bill to create a permanent tariff board was brought up in the House committee on ways and means yesterday by Republican members, but the committee indignantly postponed action through unanimous vote of the Democrats. This probably shuts off consideration of the measure at this session.

HE IS SILENT

Gompers Not Saying Anything as to the New Charges Burns Makes.

Washington, Dec. 8.—Further than to repeat his angry denials of the charges W. J. Burns makes as to his knowledge of the McNamaras' dynamiting plots, President Gompers, of the American Federation of Labor, yesterday would not discuss the statement of Burns that the Indianapolis board meeting the day after the arrest of J. J. McNamara was called to celebrate five dynamitings that were plotted for Detroit. Frank M. Ryan, president of the International Association of Bridge and Structural Iron Workers, left here at noon yesterday for Indianapolis. His departure coming right ahead of the meeting of the ways and means committee in charge of the McNamara defense confirms reports that there is a serious split in the ranks of labor leaders here to attend that meeting. It is understood that Ryan and Gompers clashed over the method of disposing of the fund. There was a marked coolness when Gompers, Mitchell, and Ryan met Wednesday, and although the scene occurred behind closed doors, it is said that Gompers attempted with the aid of Mitchell to take Ryan to task, and that the leader of the iron workers met the two half way. The committee, without Ryan, resumed its session yesterday afternoon, and will attempt to arrive at some plan for the disposition of the balance in the McNamara fund.

CHURCH BOLTS THE EDDY FOLD. Christ Scientist Congregation Declares Independence and Files Reasons. East Orange, N. J., Dec. 8.—The First Church of Christ, Scientist, of East Orange, has declared its independence of the mother church, being the second, it is said here, to secede since the church was established by Mary Baker Eddy. A declaration of independence was written and signed Wednesday night and forwarded by special delivered letter to the Boston church. Important departures from the rules of the mother church are to be inaugurated. Medical treatment for children is one and the rejection of the "Science of Health and Key to the Scriptures," of Mrs. Eddy as "guide" to conduct and in its place in the church the Bible and this textbook are the guides. The East Orange church will henceforth read into its rules that "the Bible shall be our only guide." While the textbook is thus deprived of its sacred character, it will be used in the reading, as before, alternately with the Bible. The innovation regarding treatment of children by medical doctors is said not to be in direct opposition to the tenet of Mrs. Eddy, she having advised it in certain instances. Another departure from the rule of the mother church is so to conduct the Wednesday evening meetings as eventually to provide that Christian Science treatment may be obtained free. That has not obtained thus far in any churches which adhere to the mother organization. Practitioners will be gently discouraged from collecting fees, though the acceptance of free offerings will be permitted. Two Held on Murder Charge. New York, Dec. 8.—For the murder of Isaac S. Vogel, a wealthy dealer in gems, Joseph Roberts, a negro elevator man, was held without bail by the coroner, upon charges made by detectives. Terence Vetello, a friend of Roberts, is held as a material witness. The thieves rifled the body of gems valued at \$10,000.
