Edwin Foster is ill and a trained nurse is caring for him.



GET FIVE-YEAR TERMS.

Baron Oppenheim, Howard J. Rogers Sentenced at Syracuse. Syracuse, N. Y., Nov. 9.—Baron Eugene F. E. Oppenheim of Paris, Howard J. Rogers, formerly deputy state superintendent of public instruction, and former assemblyman Richard Murphy yesterday were sentenced to five years in the United States penitentiary at Atlanta. They were found guilty on one conspiracy count and two hundred counts charging violations of the banking laws. A writ of error was granted, and an appeal will be taken.



Berlin, Nov. 9.—The statement of Premier Aquilino in his recent speech in the House of Commons that the war had brought surprises to all, elicited yesterday the following comment from Major Morah, the military writer: "The 'surprises' were the German advance in Russia, the failure of the Franco-British attack against the German west front, the great and swift success of the Austrians, Hungarians, Germans and Bulgarians in the Balkans and the insufficiency and lack of system of the allies' action in Serbia, which was carried out as though it were a reconnoitering movement in the colonies instead of a serious military operation."
