HAPPENINGS OF INTEREST FROM DIFFERENT SECTIONS

Windsor is to have city mail delivery service beginning Jan. 1.

Stephen Hallock, aged 50, and Charles Hallock, his father, aged 80 years, died at their home in Bristol Dec. 11 and 13 respectively. They were always together and even in their death were not separated long.

Stephen B. Arnold of Burlington, a merchant, yesterday filed a petition in bankruptcy in the office of Clerk F. S. Platt of the United States court. His liabilities are \$784.97 and he has assets of \$749.96, with \$150 claimed exempt. There are 25 creditors.

Chapman and Alexander, the evangelists who have been holding services in Barre for the past week or two, are accomplishing great good in that locality, large audiences being present at every meeting, with far reaching results. A Triple Ordination.

Rev. Patrick Barry and Rev. Edward J. Howard of Bellows Falls and Rev. Thomas J. Murphy of Rutland were ordained to the priesthood at St. Mary's cathedral in Burlington on Sunday, in the presence of a throng of people. The celebrant was Rt. Rev. Joseph J. Rice, who was assisted as arch priest by Rev. J. F. Gillis.

Rev. A. Hugh McKenna was the assistant to the bishop. The master of ceremonies was Rev. W. H. Cassidy. Present were Rev. J. D. Shannon, pastor of St. Charles' church, Bellows Falls, Rev. J. A. Lynch, pastor of St. John's church, Northfield, and Rev. V. Nicolai, S. S. E., of St. Michael's college, who acted as chaplain to the new priests during the mass.

Rev. W. H. Cassidy preached the sermon. In it he referred to the importance of the priesthood and the solemn and high duties and obligations of the office of the church of God. The sermon was eloquent and impressive.

The newly ordained priests will celebrate their first mass in their respective parishes. Their first solemn high mass will be celebrated Christmas day in their parishes.

The three were graduates from the Grand Seminary in Montreal, where Father McCarthy took his entire course, both at the seminary of philosophy and the seminary of theology. Father Barry and Father Howard pursued their studies at Notre Dame university, Indiana, but studied theology at the Grand Seminary.

The ceremony of ordination was witnessed by a large company of relatives and friends of the candidates from Rutland and Bellows Falls.

DEAD MAN'S FAULT.

That He Was Killed at Crossing, Says Public Service Commission.

St. Johnsbury, Dec. 21.—The Vermont public service commission has made report of its findings on two accidents near St. Johnsbury last summer, one in which Lee Hanks was killed and the other in which Morris A. Weiner and family were injured, both accidents happening at grade crossing on the Boston & Maine railroad.

In the Hanks case, which occurred at Pierce crossing between St. Johnsbury and Lyndon, the board finds that the headlight of the train (the accident happened in the early morning) must have been plainly visible to the driver of the

team as he approached the crossing and that Hanks "might, by the exercise of ordinary care, have avoided the accident, if in his senses." The fact that the remains of a bottle were found on the ground nearby and that there was evidence tending to show the smell of liquor upon Hanks led the commission to think that Hanks might have been intoxicated, although the report says nothing definite as to that.

In the Weiner case, in which an automobile was struck and pushed along the track at the Portland street crossing in St. Johnsbury on July 7, 1913, the board finds that the gatekeeper "was negligent in failing to be present and to lower said gate on the approach of said train." Mr. and Mrs. Weiner and two children were thrown out of the automobile and injured to a certain extent.
