HAPPENINGS OF INTEREST FROM DIFFERENT SECTIONS

Brattleboro is having the largest express and freight business in its history.

Wallace Harris of West Brattleboro lost the forefinger of his right hand at the middle joint a few days ago while sawing wood.

In Stowe a pair of blackbirds are often seen associating with a large flock of English sparrows, a sight not often seen. Sometimes only one blackbird is seen, but often two.

The incoming class in the Brattleboro high school this fall was equally divided between boys and girls, there being 44 of each. This is the largest class in the history of the school.

Nils Lundberg of Greensboro left his coat hanging on a cart boy recently and when he went to get it found his pocket-book containing \$85 and also some valuable papers missing.

Claude Pike, a native of Somerset, died suddenly in his carriage on the street in Enfield, Mass., recently, of heart and kidney trouble. He lived in Jacksonville until about a year ago.

Albert Charron, a Canadian farmer, who bought the Root farm of 300 acres in Benson last year, raised there this year over 2,000 bushels of oats, the biggest crop of oats ever raised in that section.

Lightning struck and burned a barn in Miltonboro owned by F. E. Goodwin Sept. 22, and nothing was saved. Six tons of hay, nine loads of oats, a separator, engine and farming tools were lost.

The steamer Alexander sank near Vergennes recently, supposedly being struck by a soft-nosed bullet from a high caliber rifle. It would carry about 100 passengers and plied between Vergennes and Westport, N. Y.

Frederick Holbrook of Brattleboro, who returned from Russia about six weeks ago with large orders for steel, sailed from New York for Russia last Wednesday, intending to open an office there and push American trade.

Twins, a boy and a girl, the former weighing 11 1/2 pounds and the latter seven pounds, were born Saturday to Mr. and Mrs. Benjamin Comier of St. Johnsbury. The boy has been named Alexander and the girl Alexandria.

The Warren E. Crafts farm in Bradford has raised some extremely large cucumbers this season, one being reported which was 15 1/2 inches long and 12 inches in circumference, weighing four and one-half pounds. There are a number of others nearly as large.

Charles Rupert, son of John H. LeBoeuf of Vergennes, had his left eye injured when an air rifle, with which his younger brother was playing, was accidentally discharged, the shot striking him in the eye. It is thought the sight will not be destroyed.

The 24th victim of poliomyelitis in Vermont was reported yesterday to Dr. Dalton, secretary of the state board of health. The case is that of a small child in a family who came to Readboro from Pittsfield, Mass., the child developing the disease at once, almost upon arriving there.

The Brattleboro board of trade has chosen Wednesday and Thursday, Oct. 4 and 5, as the dates for an automobile trip that will take the members to Montpelier, by way of Woodstock, planning to dine at the former place and to spend the night at the latter. On Thursday they will return by way of White River Junction, Hanover, Lebanon and Keene, N. H.

The first church of the Adventists stands on the Miller farm in Fair Haven, where even now some of the faithful make a yearly pilgrimage. It is said that in 1831, William Miller, called a prophet, began to foretell that on March 14, 1844, the second coming of Christ would occur, and on that day many of his converts, as well as himself, donned their ascension robes and assembled upon a hilltop to await the change, which failed to come, and after a chilly waiting returned to their homes. In the house now standing on the Miller farm are an oil painting of the prophet, his Bible, stovepipe hat and articles of furniture. The place has now been offered for sale and will soon pass out of the hands of the Miller family.

Strangely Coincident.

Careful observers of the Mexican situation were not surprised, of course, that the activities of the mysterious person called "Villa" should have been resumed at this particular time. They would rather have been surprised had he failed to put in an appearance; for the hour was ripe. The joint commission on Mexican affairs, at New London, was making certain, if slow, progress toward a settlement of the differences between the two republics; there were growing prospects of the early withdrawal of American troops from Mexican territory, and the indications were pointing to the floating of a loan that would produce funds enough to stabilize Mexican currency and put the Carranza government on its feet. In short, the conditions were altogether opportune for a bandit raid in Chihuahua, and the raid took place.

It was intended by the opportunists, north or south of the Rio Grande, that General Pershing, General Funston, General Bell, and the rest, should be convinced that it would now be safe to leave Mexico in Mexican hands. On the contrary, it was planned to convince them that salvation for Mexico lay altogether in American occupation. Continued American occupation is the one thing calculated to irritate the Mexican people, and to set loose the cry that Carranza is either a dupe or a tool of the Washington government. So, to insure a continuance of occupation, the most effective thing to do was get up a "Villa" raid. And it was gotten up, with such promptness and cleverness as leaves little doubt regarding the resources and efficiency of the anti-Carranza organization on both sides of the border.

Since the attack on Chihuahua, Guadalupe Hidalgo, Tampico and Vera Cruz have all been raided by "Villa." That individual is, apparently, very much at large, and traveling by express night and day, stopping, perhaps, only long enough to open and read his mail from the United States. It is necessary that he should be kept advised constantly with regard to the progress of the conference at New London. Otherwise he would not know how to time his raids.

Let it be reported that the joint commissioners are about to come to a general and satisfactory agreement, the result of which would be the withdrawal of American troops from Mexican territory, and the extension of American credit to the Carranza government, and "Villa's" raids will, no doubt, become more numerous and alarming than ever. But they must soon come to a stop. The conspiracy behind the bandit has run its course. Its operations have become too transparent. It is not now producing even tolerable melodrama, and some of its recent performances have bordered on the farcical.—Christian Science Monitor.
