In Brattleboro the price of milk sold from cans will be advanced May 1 from eight to nine cents, and in bottles from nine to 10 cents. Cream at that time will be advanced to 14 cents a half pint.

Mrs. Ethel Winchester met with a peculiar accident at her home in Stannard recently when she pulled over accidentally a cupboard which was full of dishes. Every dish was broken and Mrs. Winchester was injured by the falling crockery.
