Here is an alarming condition for if the farmers of Vermont plant their corn expecting it all to grow they have made it absolutely impossible for Vermont to raise more than two thirds of a crop of corn. This would be almost a calamity this year every ounce of food is necessary. The range of germination was from 0 per cent to 100 per cent. No farmer knows whether his corn will or will not grow unless he has tested it. It is a duty and a sound money practice. "Lack of food will lose the war."

Hutchins, the Northfield Coal company and the Pearl theatre. The building is a one-story building situated at the corner of Main and East streets. Principal damage to the owner of the building was in the roof, the wind tearing the entire roof from over the Trust company, the bakery and Hutchins market, and damaging it in places over the coal company and the theatre. Much damage was done to the tenants from the water, as they were completely gutted once the roof was gone. Other damage was done to the Odd Fellows hall, where the roof was also torn off. A plate glass window in the drug store of George C. Sargent was blown in and an awning in front of the jewelry store of F. S. Dyke was torn to pieces. A chimney on the tenement block of J. C. Donahue near the station was blown off and many shade and ornamental trees were blown down on various streets. Opposite the old Northfield store of George A. Sargent a large tree was blown across the electric light wires, breaking many wires and causing a fire for a few minutes, until the power could be shut off.
