That burned Phoenix building in Fitchburg, Mass., has a chance to live up to its name, with a special incentive because it was owned by a fire insurance company.

Whichever wins, it will be a pretty fight between the apple blossom and the purple aster for New Hampshire state flower, the House having voted for the former and the Senate for the latter.

Gov. Carl E. Milliken of Maine evidently is blessed with a sense of humor; he gets a good hearty laugh out of the Maine movement to nominate him for vice-president of the United States.

The town of Worcester must be added to the list of Vermont towns which voted on Tuesday in favor of licensed sale of liquor, the town perhaps believing that what's sauce for Montpelier, its neighbor, is also sauce for Worcester.

If Great Britain and France are not satisfied with the police duty being done on the Rhine by the Americans, there is one way for them to remedy the trouble, and that is by sending sufficient forces there to make up for the American army of occupation and thus relieve the American army so that it can return home.

In case there are any towns in Vermont which are willing to aid struggling street railroads, would it not be the fairer project to give them particular enabling acts rather than to impose such a possibility on every town or city located on an electric railway line, as is contemplated in Senate bill No. 73 now before the legislature?

The former automobile manufacturer who announced a short time ago that he had quit the business to seek rest and recreation now announces that he has designed a \$250 automobile which he will begin to put on the market within a short time. We cannot afford to miss the opportunity to say that this manufacturer is going to die with his rubber tires on.

The voters of Barre have an important matter to settle at a regularly called city meeting to-night, the purpose being to see whether the city will lend some very much needed assistance to the Aldrich public library to help that institution to maintain its valuable mission without impairment of service. There ought to be a good attendance and a rousing vote of support of this institution.

Gen. Sir Arthur Currie, commander of the Canadian forces in Europe during the heavy fighting on the western front, is accused by Sir Sam Hughes, former minister of militia, with sacrificing Canadian troops needlessly in order to win military fame for himself. The charge ought, of course, to be investigated; but the chances are that the accusation will not be sustained in the light of the military evidence that will be submitted in such an inquiry. It is probable that many mistakes were made on the part of the allied command during the war but that of ruthless sacrifice was not one of them.

Something must be wrong with the administrative machinery of the army in Europe when soldiers have to go without pay from August of 1918 until February, 1919, even though they have been transferred several times in the interval. A Barre soldier has written home from Europe that he doesn't have any money to spend, nor do his comrades, because the United States government hasn't paid them since the middle of last summer. The machinery of administration ought to have gotten into such working order after two years' operation that delays of this nature would not happen. The failure is all the more noticeable inasmuch as four of the seven months have been passed under cessation of fighting and without the distractions incident to conflict.

THE APPEAL TO SENTIMENT AND ARGUMENT.

If one were to judge of the value of the two speeches from the weight of the argument presented, he would be compelled to give credit to ex-President Taft for making a far stronger appeal to the great audience in New York Tuesday night in behalf of the league of nations than did President Wilson himself, the chief advocate of the machinery. Some of the reason for this difference in the quality of the two speeches may be ascribed to the fact that to ex-President Taft was assigned the work of dealing in detail with the various parts of the proposed covenant of the league of nations,

while President Wilson paid particular attention to the generalities leading up to the demand for such a league. A reading of the speeches of the two men from cold type in the newspapers would grant that President Wilson's was probably the greater oratorical attempt and most likely to please the audience; but, on the other hand, Taft's arguments for cold logic were far more convincing as to the value of the league of nations. And that, as we understand it, was largely the purpose of the farewell meeting of President Wilson—to convince the people of the United States that the league of nations should be adopted as an integral part of the treaty of peace to be signed at Paris. President Wilson's address was calculated to be received with the greater acclaim; Taft's was likely to set the minds of the audience to thinking because it came nearer to a discussion of specific details. So it was somewhat unfortunate that, from the nature of the situation, greater stress was laid by the newspapers on the address of President Wilson, while Taft's address was relegated to a position of minor importance.
