Letters From Road Chiefs. A petition from the division of highways at Springfield was read to the members of the board. The petition asked that the matter of a bit concrete road in section K, La Salle county, not be dropped, as was done in 1919. The matter was referred to the state aid roads committee.

Suit Against State. A petition was also sent in to the board from County Attorney E. E. Roberts, asking for legal assistance, the cost of which will not exceed \$200, to aid him in a damage suit against the state of Illinois. On Feb. 1, 1920, at Ames, Roberts filed suit against the state at Springfield. Recently the banks of the Illinois and Michigan canal are said to have broken, or been broken and flooded the land and crops of the County Home, west of Ottawa for which the suit was entered.


A second report was also sent in by the county attorney and was read by the clerk. The report stated that members of the board would receive \$3 per day for their work outside of their home town and \$2.50 per day for work done inside their town. The report further stated that the legislature changed method of payment of compensation to members of the board. Their fees are now payable out of the county treasury, instead of out of the town fund.

At the 15 o'clock session of the board a committee was named to obtain pictures of the late Henry Mayo of Ottawa, judge of the county court, and of the late A. T. Larkin of Ottawa, judge of the Probate Court, to be taken to the Getting art gallery of Ottawa and properly framed at the expense of the county and to be placed in the court house, as records of their judicial work. The committee announced that the pictures were obtained and presented them to the board for inspection.

Four bills from Sheriff C. S. Ayers for traveling expenses were presented to the board. They totaled \$162.19. The board then adjourned until 10 o'clock tomorrow morning.

SEEK SLAYER OF WIFE OF CAMP GRANT CAPT. (By the Associated Press) Rockford, Ill., June 15.—Five soldiers of Camp Grant, near here, were sought today in connection with the shooting to death early today of Mrs. Maud Lucille Moss, wife of Captain Leroy H. Moss, camp military officer and daughter of Colonel Ben J. Arnold, pioneer electrical engineer. It was reported early today that the men were believed surrounded.
