SUNDAY POLICE COURT HERE ALSO

Innovation Introduced at Chicago in Vogue in Rock Island for Years.

Various Chicago newspapers have during the past few weeks devoted columns of space to the holding of Sunday morning police court in several of the temples of justice.

Although it is not generally known, this practice has been followed by Magistrate Smith in Rock Island ever since he has held that office. The plans of both Rock Island and Chicago are identical.

Prisoners arrested Saturday night would be compelled to lie in jail one day and two nights should the trials be deferred until Monday.

Early Sunday morning the judge reports for duty at his court and examines the prisoners. Those not held for serious offenses are permitted to go to their homes, upon their promise to return for trial the following morning.

The men are placed upon their honor in most instances, and there have been but few abuses. In some cases bonds are furnished and in others a cash deposit is left with the desk sergeant

General Secretary Wirt Taylor's Successor to Be Chosen at Thursday Meeting.


The annual meeting of the Associated charities will be held Thursday afternoon, Oct. 2, at 4 o'clock at the Association House, 637 Seventeenth street.


AUTOMOBILE SMASHES A PAINTER'S WAGON
