ARTICLES OF INCORPORATION OF MCCORMICK LUMBER COMPANY.

ARTICLE 1.
 The name of the corporation shall be "McCormick Lumber Company," and its principal place of business shall be at Deland, Volusia county, Florida, with places of business at such other places in the State of Florida or elsewhere as may be desired, in the discretion of the Board of Directors.

ARTICLE 2.
 The general nature of the business or businesses to be transacted shall be to own, manage and control by purchase, lease or otherwise, and to construct, maintain and operate for profit saw mills planing mills, shingle mills, box and veneer mills and lumber yards, and to manufacture, buy, sell and deal in any of the products thereof, and in all building materials either at wholesale or retail; to contract for the cutting of timber for others and for the manufacturing of the same into lumber or any lumber products to buy, sell, lease, rent, sublet, mortgage, pledge and convey, or acquire, encumber and dispose of in any lawful manner, real estate, timber and other property of said corporation or any part thereof, to build and contract for the building of houses and other structures and to buy, sell, rent, lease, or otherwise acquire and dispose of the same, and to do all acts incidental to or necessary for the maintenance and carrying on of the business of the Corporation.

ARTICLE 3.
 The amount of the capital stock shall be \$125,000, divided into one hundred and fifty shares of the par value of \$100.00 a share; \$75,000 of which shall be paid in upon the incorporation of the Company, and the balance as called for by the Board of Directors. Any part of the capital stock may be payable in property, labor or services at a just valuation to be fixed by the incorporators, or by the Board of Directors at a meeting called for such purpose; and property, labor or services may also be purchased or paid for with capital stock at a just valuation of such property, labor or services, to be fixed by the directors of the Company at a meeting called for such purpose.

ARTICLE 4.
 The term for which the corporation shall exist is perpetual as provided by law.

ARTICLE 5.
 The business of the corporation shall be managed and conducted by President, Secretary and Treasurer, (but the officers of Secretary and Treasurer may be held by the same party) and a Board of Directors consisting of not less than three, to be fixed by the by-laws, and such other officers and agents as the corporation may authorize. The president, secretary, treasurer and board of directors shall hold office for the period of one year and until their successors are elected and qualified, and such other officers or agents for such time as may be prescribed by the by-laws. The first election under this charter shall be held on the first Monday in July, 1906, and annually thereafter on the said first Monday in July in each year. The business of the Company shall be managed and conducted by the following named persons until those elected at the first election shall be qualified, to-wit:

ARTICLE 6.
 The highest amount of indebtedness to which the corporation can at any time subject itself is \$15,000.
