

## ORDINANCE NO. 142

### An Ordinance Establishing and Fixing the Boundaries of Certain Election Precincts in the County of San Diego, California, to be known as Alpine, El Centro, Foster, Imperial (outside), Lakeside, Ramona, West Fallbrook and San Luis Rey Election Precincts.

The board of supervisors of San Diego county do ordain as follows:

Section I. Said board of supervisors do hereby establish the following election precincts in the county of San Diego California, known as Alpine, El Centro, Foster, Imperial (outside), Lakeside, Ramona, West Fallbrook and San Luis Rey election precincts.

#### Section II.—

##### ALPINE ELECTION PRECINCT.

The boundaries of said precinct shall be as follows:

Beginning at the N. W. Cor. of Sec. 22, Twp. 15 S., R. 1 E., S. B. M. Thence East along section lines to the S. W. Cor. of Sec. 13 of said Twp. Thence North to the N. W. Cor. of the S. W. 1-4 of said Sec. 13; Thence East to the N. E. Cor. of the S. E. 1-4 of Sec. 18, Twp. 15 S., R. 2 E. Thence South to the S. E. Cor. of said Sec. 18; Thence East to the S. E. Cor. of Sec. 13 of said Twp. Thence North to the N. W. Cor. of Sec. 18, Twp. 15 S., R. 3 E. Thence East along section lines to the N. E. Cor. of Sec. 17 of said Twp. Thence South to the S. E. Cor. of said Sec. 17; Thence East to the N. E. Cor. of Sec. 21 of said Twp. Thence South to the S. E. Cor. of Sec. 33 of said Twp; Thence west to the S. W. cor of Sec. 31 of said Twp; thence south to the S. E. Cor. of the N. E. 1-4 of Sec. 1, Twp. 16 S., R. 2 E. Thence West to the S. W. Cor. of the N. W. 1-4 of Sec. 5 of said Twp. Thence North to the N. W. Cor. of said Sec. 5; Thence West to the S. W. Cor. of Sec. 36, Twp. 15 S., R. 1 E. Thence North to the N. W. Cor. of said Sec. 36; Thence West to the S. W. Cor. of Sec. 27 of said Twp. Thence North to the N. W. Cor. of Sec. 22 of said Twp. and the place of beginning.

#### Section III.—

##### EL CENTRO ELECTION PRECINCT

The boundaries of said El Centro election precinct shall be as follows:

Commencing at the N. E. corner of Section 24, Twp. 15 S., R. 14 E., S. B. M.; thence running South to the S. E. corner of Section 13, Twp. 16 S., R. 14 E.; thence West to the S. W. corner of Section 18, Twp. 16 S., R. 14 E.; thence North to the N. W. corner of Section 31, Twp. 15 S., R. 14 E.; thence West to the S. W. corner of Section 27, Twp. 15 S., R. 13 E.; thence North to the N. W. corner of Section 22, Twp. 15 S., R. 13 E.; thence East 2 1-2 miles to quarter section corner on quarter section line running North and South through center of Section 24, Twp. 15 S., R. 13 E.; thence S. 1-2 mile on said quarter section line to center of said Section 24; thence East 2 1-2 miles to quarter section corner on West line of Section 21, Twp. 15 S., R. 14 E.; thence North 1-2 mile to N. W. corner of said section 21; thence East 4 miles to place of beginning.

#### Section IV.—

##### FOSTER ELECTION PRECINCT.

The boundaries of said Foster election precinct shall be as follows:

Commencing at N. E. corner of Section 8, Twp. 14 S., R. 1 East, S. B. M.; thence South to S. E. corner of Section 29, said Twp. 14 S., R. 1 E.; thence West one mile to S. W. corner of said Section 29; thence South three miles to S. E. corner of said Section 7, Twp. 15 S., R. 1 E.; thence West three miles to S. W. Corner of Section 11, Twp. 15 S., R. 1 W.; thence North 6 miles to N. W. Cor. of Sec. 14, Twp. 14 S., R. 1 W.; thence East two miles to S. W. corner of Section 7, Twp. 14 S., R. 1 E.; thence North one mile to N. W. corner of said Section 7; thence East 2 miles to place of beginning.

#### Section V.—

##### IMPERIAL (outside) ELECTION PRECINCT.

The boundaries of said Imperial (outside) election precinct shall be as follows:

Commencing at the N. E. corner of Section 24, Twp. 14 S., R. 14 East, S. B. M.; thence West to the N. W. corner of Section 22, Twp. 14 S.; R. 13 E.; thence south to S. W. Cor. of Sec. 15, Twp. 15 S., R. 13 E. Thence East 2 1-2 miles to the quarter section corner on quarter section line running North and South through center of section 24, Twp. 15 S., R. 13 E.; thence South 1-2 mile to center of said section 24; thence East 1-2 mile to quarter section corner on East

line of said section 24; thence North 2 miles to quarter section corner on East line of Section 12, Twp. 15 S., R. 13 East; thence East 2 miles on quarter section line to quarter section corner on East line of Section 8, Twp. 15 S., R. 14 E.; thence South 1 1-2 miles to S. W. corner of Section 16, Twp. 15 S., R. 14 E.; thence East 4 miles to S. E. corner of section 13, Twp. 15 S., R. 14 E.; thence North 6 miles to place of beginning.

#### Section VI.—

##### LAKESIDE ELECTION PRECINCT.

The boundaries of said Lakeside election precinct shall be as follows:

Beginning at the N. E. Cor. of Sec. 1. Twp. 14 S., R. 2 E. Thence South to the S. E. Cor. of Sec. 12 of said Twp. Thence East to the N. E. Cor. of Sec. 18, Twp. 14 S., R. 3 E. Thence South to the S. E. Cor. of Sec. 19 of said Twp. Thence West to the S. W. Cor. of said Sec. 19; Thence South to the S. E. Cor. of Sec. 13, Twp. 15 S., R. 2 E. Thence West to the S. W. Cor. of Sec. 17 of said Twp. Thence north to the S. E. Cor. of the N. 1-2 of Sec. 13 of said Twp. Thence west to the S. W. Cor. of the N. 1-2 of Sec. 13, Twp. 15 S., R. 1 E. Thence south to the S W Cor. of said Sec 13; Thence west to the S W Cor of Sec 15 of said Twp. Thence south to the S E Cor of Sec 28 of said Twp. Thence west to the S W Cor of Sec 25 Twp 15 S, R 1 W. Thence north to the S E Cor. of the N 1-2 of Sec. 23 said Twp. Thence west 40 chs. Thence north 70 deg. 10 W 42.02 chs to a Cor. between subdivisions "B" and "T" of the Rancho El Cajon; Thence north to the N W Cor of Sec 14, Twp 15 S, R 1 W. Thence east to the S E Cor of Sec 7 of Twp 15 S, R 1 E. Thence north to the N W Cor of Sec 32, Twp 14 S, R 1 E. Thence east to the N E Cor of said Sec 32; Thence north to the N W Cor of Sec 4 of said Twp. Thence east to the place of beginning.

#### Section VII.—

##### RAMONA ELECTION PRECINCT

The boundaries of said Ramona Election Precinct shall be as follows:

Commencing at the S E corner of section 5. Twp 14 S, R 1 E., S. B. M., thence west 2 miles to the S E corner of Section 1. Twp 14 S, R 1 W, thence south one mile to the S E corner of section 12, Twp 14 S, R 1 W; thence west 2 miles to the S W corner of section 11, Twp. 14 S, R 1 W, thence north 2 miles to the N W corner of section 2, Twp 14 S, R 1 W; thence west one mile to the S W corner of section 34, Twp 13 S, R 1 W.; thence north 3 miles to the N W corner of Section 22, Twp 13 S, R 1 W; thence East one mile to the NE corner of said section 22; thence north 2 miles to N W corner of section 11, Twp 13 S, R 1 W; thence east 2 miles to S W corner of section 6, Twp 13 S, R 1 E; thence north one mile to N W corner of said section 6; thence east 2 miles to the N E corner of section 5, Twp 13 S, R 1 E; thence north 6 miles to N W corner of section 4, Twp 12 S, R 1 E; thence east 4 miles to the N E corner of section 1, Twp 12 S, R 1 E; thence south 6 miles to the S E corner of section 36, Twp 12 S, R 1 E; thence east one mile to the N E corner of section 6, Twp 13 S, R 2 E; thence south 3 miles to the S E corner of section 18, Twp 13 S, R 2 E; thence east to the N E corner of section 21, Twp 13 S, R 2 E; thence south 3 miles to the S E corner of section 33, Twp 13 S, R 2 E; thence west 7 miles to the N E corner of section 5, Twp 14 S, R 1 E; thence south one mile to place of beginning.

#### Section VIII.—

##### WEST FALLBROOK ELECTION PRECINCT

The boundaries of said West Fallbrook Election Precinct shall be as follows:

Beginning on the north line of San Diego County where said line is intersected by the section line between sections 21 and 22, Twp 8 S, R 4 W, S. B. M. Thence south-easterly, southerly and east along the north line of said County to the N E corner of Sec 3, Twp 9 S, R 3 W. Thence south to the S E corner of said Sec 3; Thence west to the S W corner of said Sec 3. Thence south to the S E corner of Sec 9 of said Twp; thence west to the S W corner of section 8 of said Twp. Thence south to the S E corner of Sec 19 of said Twp. Thence west to the S W Cor of the S E 1-4 of section 19; Thence south to the S E corner of the S W 1-4 of Sec 30 of said Twp 9 S, R 3 W. Thence east to the N E corner of Sec 31 of said Twp. Thence south to the S E corner of Sec 6, Twp 10 S, R 3 W. Thence west to the S W corner of the S E 1-4 of said Sec 6; Thence south to the S E corner of the S W 1-4 of Sec 18, Twp 10 S, R 3 W; Thence west along the section line to its intersection with the Santa Margarita Ranch line; Thence S W along said Ranch line to its intersection with

section line between Sections 27 and 28 Twp 10 S. R 4 W. Thence north along section lines to place of beginning.

#### Section IX.—

##### SAN LUIS REY ELECTION PRECINCT

The boundaries of said San Luis Rey Election Precinct shall be as follows:

Beginning on the Coast line of the Pacific Ocean where said line is intersected by the boundary between Orange and San Diego Counties; Thence north along said boundary line to the north line of the Santa Margarita Rancho; Thence in an easterly direction along the north line of said Rancho to east line of Twp 8 S, R 6 W; Thence S to the S E corner of said Twp. Thence west to the N E corner of Twp 9 S, R 6 W. Thence south to the S E corner of section 25 of said Twp. Thence east to the N E corner of section 31, Twp 9 S, R 5 W; Thence south to the S E corner of section 31: Thence east to the N E corner of section 4, Twp 10 S, R 4 W. Thence south along section line to the southerly boundary line of the Santa Margarita Rancho; Thence northeasterly along said boundary line to its intersection with the north line of section 23 of Twp 10 S, R 4 W. Thence east to the N E corner of section 24 of said Twp Thence south to the S E corner of section 12, Twp 11 S, R 4 W; Thence west to the S W corner of said section 12; Thence south to the S E corner of section 23 of said Twp. Thence west to the south west corner of said section 23; Thence south to the S E corner of section 34 of said Twp. Thence west to the S W corner of section 32 of said Twp Thence north to the N W corner of said section 32; Thence west to the east boundary of the City of Oceanside. Thence following the east and north boundaries of said city to the coast line of the Pacific Ocean; Thence north-west along said coast line to the place of beginning.

Section X—The forgoing several election precincts are hereby established and declared valid and existing election precincts in the County of San Diego and the boundaries of said several election precincts shall be as hereinbefore fixed and determined.

Section XI—This ordinance shall take effect and be in force from and after the 13th day of August, 1906. Before the expiration of the time intervening the same shall be published with the names of the members voting for and against the same, for one week in the Ramona Sentinel, Imperial Press, El Cajon Valley News, Fallbrook Review, newspapers printed and published in the County of San Diego, California.

Approved and adopted this 24th day of July, 1906.
