

Ordinance No. 157

An ordinance dividing the proposed new county to be called Imperial County, into a convenient number of judicial townships, voting precincts, road and school districts, defining their respective boundaries and designating the names of such districts; and also dividing said proposed new county into five Supervisorial districts and numbering said districts.

The Board of Supervisors of the County of San Diego, pursuant to the provisions of an act of the Legislature approved March 15th, 1907, and entitled "An Act to provide for the formation, organization and classification of new counties, for locating the county seats, for the election and appointment of officers, and for the adjustment and fulfillment of the rights and obligations arising between such new counties and other counties," do ordain as follows:

Section 1. The Judicial township of Calexico, in the proposed county of Imperial, is hereby created and established, and the boundaries of said township are hereby fixed and established as follows:

Commencing at the intersection of the range line between ranges 8 and 9 east, S. B. M. and the boundary line between the United States and Mexico, and running thence north along said range line to its intersection with the 4th Standard line south, thence east along said line between townships 16 and 17 south to the southwest corner of section 35, T. 16 S., R. 14 E., S. B. M., thence north along the west line of said section to the N. W. corner thereof, thence east along the north lines of section 35 and 36, T. 16 S., R. 14 E. to the N. E. corner of said section 36, thence north along the west lines of section 30 and 19, T. 16 S., R. 15 E. to the N. W. corner of said Sec. 19, thence east 18 miles more or less along the section lines to the S. W. corner of section 18, T. 16 S., R. 18 E., thence north along the range line to the N. W. corner of Sec. 6, T. 16 S., R. 18 E. thence east along the township line to the N. E. corner of section 1, T. 16 S., R. 18 E., thence south along the range line between ranges 18 and 19 east to its intersection with the boundary line between the United States and Mexico. Thence in a westerly direction along said boundary line to the place of beginning.

Section 2. The Judicial township of Silsbee in the proposed county of Imperial, is hereby created and established, and the boundaries of said township are hereby fixed and established as follows:

Beginning at the S. W. corner of Township 16 south, range 9 east, S. B. M., and running thence north along the range line between ranges 8 and 9 east, to the N. W. corner of Section 19, T. 15 S., R. 9 E., thence east 26 miles, more or less, along the section lines, to the N. E. corner of Sec. 20, T. 15 S., R. 13 E., thence south along the east lines of Sec. 20, 29 and 32, T. 15 S., R. 13 E., to the S. E. corner of said Sec. 32, thence east along the township line to the north 1-4 corner of Sec. 1, T. 16 S., R. 13 E., thence south along the center lines of sections 1, 12, 13, 24, 25 and 36, T. 16 S., R. 13 E., to the south 1-4 corner of said Sec. 36, thence west along the township line between townships 16 and 17 south, to the place of beginning.

Section 3. The Judicial township of El Centro, in the proposed county of Imperial, is hereby created and established, and the boundaries of said township are hereby fixed and established as follows:

Commencing at the south 1-4 corner of section 36, T. 16 S., R. 13 E., S. B. M., and running thence north along the center lines of sections 36, 25, 24, 13, 12 and 1, T. 16 S., R. 13 E., and sections 36 and 25, T. 15 S., R. 13 E., to the center of said section 25, thence east along the center line of said section 25, and the center line of section 30 and 29, T. 15 S., R. 14 E. to the east 1-4 corner of said section 29, thence north along the east line of said section 29 to the northeast corner thereof, thence east along the north lines of sections 28, 27, 26, 25, T. 15 S., R. 14 E., to the N. E. corner of said section 25, thence south along the range line between ranges 14 and 15 E., to the S. E. corner of section 25, T. 16 S., R. 14 E., thence west along the south lines of said section 25 and also section 26, T. 16 S., R. 14 E., to the S. W. corner of said section 26, thence south to the S. E. corner of section 34, T. 16 S., R. 14 E., thence west along the township line between townships 16 and 17 S., to the place of beginning.

Section 4. The Judicial township of Imperial in the proposed county of Imperial, is hereby created and established and the boundaries of said township are hereby fixed and established, as follows:

Commencing at the S. W. corner of section 18, T. 15 S., R. 9 E., S. B. M., and running thence north along the range line between ranges 8 and 9 east, S. B. M., to the N. W. corner of T. 9 S., R. 9 E., thence east along the north line of T. 9 S., to the N. E. corner of T. 9 S., R. 12 E., thence south along the range line between ranges 12 and 13 E., to the S. E. corner of T. 10 S., R. 12 E., thence west along line between T. 10 and T. 11 S., to the S. W. corner of T. 10 S., R. 11 E., thence south along range line between ranges 10 and 11 E., to the N. E. corner of section 24, T. 14 S., R.

10 E., thence east along the section lines to the N. E. corner of section 24, T. 14 S., R. 14 E., thence south along the range line between ranges 14 and 15 E. to the S. E. corner of section 24, T. 15 S., R. 14 E., thence west along the south lines of sections 24, 23, 22, 21, T. 15 S., R. 14 E., to the S. W. corner of said section 21, thence south to the east 1-4 corner of section 29, T. 15 S., R. 14 E., thence west along the center line of said section 29, and 30, and section 25, T. 15 S., R. 13 E., to center of said section 25, thence south along the center lines of said section 25 and 36 to the south 1-4 corner of said section 36, T. 15 S., R. 13 E., thence west along the south boundary of T. 15 S., R. 13 E., to the S. W. corner of section 33, same township and range, thence north along the section lines to the S. E. corner of section 17, T. 15 S., R. 13 E., thence west along the section lines to the place of beginning.

Sec 5. The Judicial township of Brawley, in the proposed county of Imperial, is hereby created and established and the boundaries of said township are hereby fixed and established as follows:

Commencing at the S W corner of section 18, T. 14 S, R 11 E, S. B. M. Thence running north along the range line between ranges 10 and 11 E., to the N W corner of T 12 S, R 11 E., thence east on the township line between townships 11 and 12, to the N. E. corner of township 12 S, R 15 E. thence south along the range line between ranges 15 and 16 E to the S E corner of section 13, T 14 S., R 15 E., thence west along the section lines to the place of beginning.

Section 6. The Judicial township of Old Beach, in the proposed county of Imperial, is hereby created and established, and the boundaries of said township are hereby fixed and established as follows:

Commencing at the S W corner of T 11 S R 11 E, thence running north along the west line of said township line, thence running east along the township line between townships 10 and 11 south to the S W corner of T 10 S, R 13 E, thence running north along the range line between ranges 12 and 13 E to the northwest corner of T 9 S, R 13 E, thence running east along north line of T 9 S to the N E corner of T 9 S, R 17 E, thence running south along the range line between ranges 17 and 18 east to the S E corner of section 24, T 12 S, R 17 E, thence running west along the section lines to the S W corner of section 19, T 12 S, R 16 E, thence running north along the range line between ranges 15 and 16 E to the S W corner of section 31, T 11 S, R 16 E, thence west

along the township line between townships 11 and 12 south, to the place of beginning.

Section 7. The Judicial township of Holtville, in the proposed county of Imperial, is hereby created and established and the boundaries of said township are hereby fixed and established as follows:

Commencing at the S W corner of section 18, T 16 S, R 15 E, S. B. M., thence running north along the range line between ranges 14 and 15 east to the N W corner of section 19, T 14 S, R 15 E, thence running east along the north line of sections 19, 20, 21, 22, 23 and 24, T 14 S, R 15 E to the N E corner of said section 24, thence north on the range line between ranges 15 and 16 E to the N W corner of section 30, T 12 S, R 16 E, thence east 12 miles, more or less, along the section lines, to the N E corner of section 25, T 12 S, R 17 E, thence south along the range line between ranges 17 and 18 E to the S E corner of section 13, T 16 S, R 17 E, thence west along the section line to the place of beginning.

Section 8. The Judicial township of Palo Verde, in the proposed county of Imperial, is hereby created and established, and the boundaries of said township are hereby fixed and established as follows:

Commencing at the S W corner of section 31, T 15 S, R 18 E, S. B. M., thence running north along the range line between ranges 17 and 18 east to the N W corner of T 9 S, R 18 E, thence east along the north line of said T 9 S to the eastern boundary of the State of California, thence following the eastern boundary line of the state of California in a southerly direction, to its intersection with the township line between townships 12 and 13 S, thence west along said township line to the N W corner of T 13 S, R 22 E, thence south along range line between ranges 21 and 22 east, to the S E corner of T 14 S, R 21 E, thence west along township line between townships 14 and 15 south to the S W corner of T 14 S, R 19 E, thence south along range line between ranges 18 and 19 E to the S E corner of T 15 S, R 18 E, thence west along township line between townships 15 S and 16 S to place of beginning.

Section 9. The Judicial township of Hanlon, in the proposed county of Imperial, is hereby created and established, and the boundaries of said township are hereby fixed and established as follows:

Commencing at the intersection of the range line between ranges 18 and 19 east where said line intersects the southern boundary of the United States thence running north along said range line to the N W corner of T 15 S, R 19 E, thence running east along the township line between townships 14 and 15 S to the N E corner of T 15 S, R 21 E, thence south on range line between ranges 21 and 22 E, to a point directly east of the south line of section 10, T 16 S, R 21 E, on the Yuma Indian reservation; thence east to the eastern boundary of the state of California; thence in a southwesterly direction along the eastern boundary of the state of California to the point where said eastern boundary of the state of California intersects the southern boundary of the United States, thence west along the southern boundary of the United States to the place of beginning.

Section 10. The Judicial township of Laguna, in the proposed county of Imperial, is hereby created and established and the boundaries of said township are hereby fixed and established as follows:

Commencing at the N W corner of T 15 S, R 22 E, S. B. M., thence running east along the township lines between townships 14 and 15 S to its intersection with the eastern boundary of the state of California, thence in a southwesterly direction along the eastern boundary of the state of California to a point thereon directly east of the south line of section 10, T 16 S, R 21 E, thence west to a point on the range line between ranges 21 and 22 E, or such line produced, thence north along said range line to the place of beginning.

Section 11. The Judicial township of Picacho, in the proposed county of Imperial, is hereby created and established, and the boundaries of said township are hereby fixed and established as follows:

Commencing at the S W corner of section 31, T 14 S, R 22 E, thence running north along the range line between ranges 21 and 22 E to the N W corner of section 6, T 13 S, R 22 E, thence running east along the township line between T 12 S and 13 S to the eastern boundary of the state of California, thence in a southwesterly direction along the eastern boundary of the

state of California to the intersection of the township line between townships 14 and 15 S and the said state boundary line, thence west along said line between townships 14 and 15 S to the place of beginning.

Section 12. All ordinances heretofore passed establishing, creating and fixing the boundaries of the judicial townships herein in this ordinance mentioned are hereby repealed and said judicial townships herein and hereby created and established shall consist of the territory herein in this ordinance mentioned and of no other territory and the boundaries of said respective townships shall be as hereby created and established and any and all ordinances in conflict herewith are hereby repealed.

Section 13. The proposed new county of Imperial county is hereby divided into the following election precincts to be named as herein mentioned and to contain the territory herein provided for and the boundaries of said election precincts shall be as is herein in this ordinance set forth.

Section 14. Calexico precinct: The voting precinct of Calexico is hereby established and created and the boundaries of said Calexico voting precinct shall be the same as the boundaries of Calexico Judicial township as set forth in section 1 of this ordinance.

Section 15. Silsbee precinct: The voting precinct of Silsbee is hereby established and created and the boundaries of said Silsbee voting precinct shall be the same as the boundaries of Silsbee Judicial township as set forth in section 2 of this ordinance.

Section 16. El Centro precinct: The voting precinct of El Centro is hereby established and created and the boundaries of said El Centro voting precinct shall be the same as the boundaries of El Centro judicial township as set forth in section 3 of this ordinance.

Section 17. Brawley Precinct: The voting precinct of Brawley is hereby established and created and the boundaries of said Brawley voting precinct shall be the same as the boundaries of Brawley Judicial township as set forth in section 4 of this ordinance.

Section 18. Old Beach Precinct: The voting precinct of Old Beach is hereby established and created and the boundaries of said Old Beach voting precinct shall be the same as the boundaries of Old Beach Judicial township as set forth in section 5 of this ordinance.

Section 19. Holtville Precinct: The voting precinct of Holtville is hereby established and created and the boundaries of said Holtville voting precinct shall be the same as the boundaries of Holtville Judicial township as set forth in section 6 of this ordinance.

Section 20. Palo Verde Precinct: The voting precinct of Palo Verde is hereby established and created and the boundaries of said Palo Verde voting precinct shall be the same as the boundaries of Palo Verde Judicial township as set forth in section 7 of this ordinance.

Section 21. Hanlon precinct: The voting precinct of Hanlon is hereby established and created and the boundaries of said Hanlon voting precinct shall be the same as the boundaries of Hanlon Judicial township as set forth in section 8 of this ordinance.

Section 22. Laguna Precinct: The voting precinct of Laguna is hereby established and created and the boundaries of said Laguna voting precinct shall be the same as the boundaries of Laguna Judicial township as set forth in section 9 of this ordinance.

Section 23. Picacho Precinct: The voting precinct of Picacho is hereby established and created and the boundaries of said Picacho voting precinct shall be the same as the boundaries of Picacho Judicial township as set forth in section 10 of this ordinance.

Section 24. Imperial Voting precinct No. 1 shall consist of the following territory and is bounded and described as follows:

Sections 17 and 18, south half, section 7 and 8 and north half of sections 19 and 20 all of township 15 south, range 14 east.

Section 25. Imperial voting precinct No. 2, shall consist of the following territory and is bounded and described as follows:

Commencing at the S W corner of section 18, T 15 S, R 9 E, S. B. M., and running thence north along the range line between ranges 8 and 9 east S. B. M. to the N. W. corner of T 9 S, R 9 E, thence east along the north line of T 9 S, to the N E corner of T 9 S, R 12 E, thence south along the range line between ranges 12 and 13 E to the S E corner of T 10 S, R 12 east, thence west along line between T 10 and
