Urge His Defeat to  
Redeem Reputation

FORT WORTH, Tex., May 8.—(By the Associated Press)—Referring to United States Senator James A. Reed as a "marplot," former Governor Lan V. Stephens, aided the defeat of the Missouri's senior senator in "redeem the reputation of the democratic party."

It was Mr. Wilson's third letter to the editor of the democratic newspaper of the state, the *Missouri State Journal*, in which he urged the defeat of Senator Reed.
