State Fair at Tampa.

Tampa intends holding, next winter, a grand state fair, and judging from the success achieved last year at the South Florida Fair and Mid-Winter Exposition, the undertaking will be the most successful ever held in a Southern state. The recent fair outstripped any ever held in Florida, both in point of attendance and character of exhibits, for which the largest prizes ever given in a Southern state were awarded, and it is intended that the next fair, to include all counties in the state instead of only those in the southern section, shall eclipse the first in every way. The high officials of railways traversing and otherwise interested in Florida, are greatly interested in the movement and have proffered their hearty co-operation in the matter of securing low rates from other states, in advertising the fair and State and in securing exhibits, which will be transported to Tampa free of charge by railways, steamship lines and express companies.

Tampa, being possessed of the largest and most conveniently located fair grounds in the State, also hotel accommodations for thousands, is in every way equipped for holding such a fair. To carry out the gigantic plans of the movement, the Florida State Mid-Winter Fair Association is being organized, the officers, directors and stockholders of which are to be chosen from every county in the State in order that all may have absolutely equal representation. Mr. T. J. L. Brown, who inaugurated the South Florida Fair and pushed it to success, is behind the new movement, which is a guarantee of its success.
