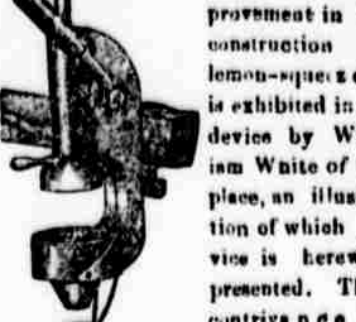
Released by writ of Habeas Corpus Mrs. Cora Kile, who was placed in jail under an order of commitment issued by Judge Tannehill, was released from jail Tuesday on a writ of habeas corpus granted by B. T. Hainer, judge of the district court of Beaver county. The writ of habeas corpus was granted in answer to a petition by Carter Tracy attorney for Mrs. Kile. The writ, which ordered that the prisoner be released immediately, was issued on the ground that imprisonment appeared to the judge to be illegal from the evidence set forth in the petition.

Contest Case Decided. In the contest case of Steven D. Elliot vs. John Homan, for homestead entry number 2739, a decision has been rendered by the General Land office in favor of John Homan, contestant. The testimony in this case was taken before the deputy district clerk, Mr. Ballinger, at Beaver, in November, 1899. Attorneys Griggs and Ballinger appearing for the contestant and attorney Loeffelbourn and Tracy for the contestee. The Woodward Land Office rendered a decision in favor of the contestant. An appeal to the General Land office was taken from this decision by C. W. Herod attorney for the contestant. A reply to this appeal being made by Tracy attorney for the contestee. The decision given by the Woodward Land office was affirmed by the General Land Office. The case in the case amounted to about a hundred dollars, principally on the part of contestee.

A NEW LEMON-SQUEEZER

William White of Denver the Inventor of a Device for Squeezing Lemons



A decided improvement in the construction of a lemon-squeezer is exhibited in the device by William White of this place, an illustration of which device is herewith presented. This contrivance is simple, light and durable. It may be readily adjusted to a table, and works with such force that the juice of a lemon may be extracted with but little effort.

This lemon-squeezer is provided with an attachment for holding a glass or other receptacle into which the juice of the lemon is directed. The device has a clamp with upper and lower jaws and may be fastened to a support by means of a clamping screw on the lower jaw. The inner surfaces of the halves of the casing fit securely together. The under surface of the upper section is hollowed for the reception of a gear, the teeth of which mesh with those of a corresponding plunger underneath. The upper cup is so constructed that when it is brought down, it admits of a rotary movement which aids in extracting the juice from the lemon. The cup into which the lemon juice is poured is attached to the squeezer so that the operator is free to use both hands in manipulating the device.

Mr. White has secured a patent for this invention, but has not yet placed the squeezer on the market. He has received numerous propositions from manufacturers throughout the country regarding the manufacture of the squeezer but none of these propositions have been accepted. The device is handy and inexpensive and ought to meet with a ready sale.

MORE CASES OF SMALLPOX

Thirteen Cases at Liberal—Reports of Many Cases at Optima Township—Board of Health Meets

News was received from Liberal today that there are thirteen cases of smallpox in that city. All these are under strict quarantine. Ten of the small pox victims are held in the post house three are quarantined at their homes. At a citizens' meeting held there yesterday resolutions were passed respecting quarantine regulations. Three special marshals are employed to assist in the maintenance of a proper quarantine. The county board of health of that place have, it is understood, sent for a state health officer to inspect the small pox cases.

Of the cases reported at Liberal, some are of a severe nature and others of a mild form. There seems to be no doubt that the disease is smallpox. The small pox symptoms are as pronounced as to leave no doubt as to the nature of the disease. During the first stages, the symptoms resemble those of a cold. The victim is taken with a headache and fever and after three or four days eruptions make their appearance. In some instances the patients are almost entirely covered with eruptions, in which case the severity of the disease can hardly be imagined.

There are reports of many cases of small pox along the new railroad now building in this county. These reports though indefinite come from reliable sources, and in consequence the county board of health has requested the Territorial board to investigate the situation at once. Dr. Munnell, the only physician at this place though a member of the county board, has important cases of sickness here demanding his attention, so that it is impossible for him to go to Optima to stay, hence the request for the Territorial board to make an investigation.

OBITUARY

Death of Jacob Redemer of Woodbine. Ill. Father of Casper Redemer of This Place.

Mr. Jacob Redemer, of Woodbine, Illinois, father of George and Casper Redemer of this county, died on the 2d inst. The following obituary notice appeared in the Galesburg (Ill.) Gazette of the 7th. Mr. Jacob Redemer was born in Schweinfurt, Bavaria, Germany Oct. 31st, 1814. He went to the public school from his sixth to his thirteenth year. After his confinement he learned the blacksmith trade and as the law of the state required, he resided until 1843, then he came back to the town where he was born and worked at the blacksmith trade in that community and was also a noted coal burner. In the winter of 1844, he was married to Miss Margaret Hess and the Lord blessed their union with nine children; two died in infancy, and four daughters and three sons are living in this country. They landed in Galesburg July 18, 1850, and a few days afterwards they moved on a farm in Woodbine township, where they spent the rest of their lives. Two months ago his wife died, and since then he has been gradually failing, until the 2d of March 1901, at 6 o'clock when he died of old age. He was 86 years, 4 months, and 2 days old. The funeral services were held at the German M. E. church Monday, 4th, Rev. Casper Hess officiating. He leaves to mourn his loss seven children, namely: Mrs. John Stahl, Mrs. Mrs. John Schneider of Apple River, Mrs. John Haas and Mrs. Charles Burke of Woodbine, Casper and George of Oklahoma and John A. of Woodbine, who, together with a grandson, Casper Redemer, performed the final duties in caring for his aged father. The deceased was a good husband and father, and leaves a host of friends to mourn his death.
