THE WAY OF THE TRANSFEROR.

Ed. Young Sent up for Stealing Money Out of the County Treasurer's Office—A Shrewd Thief.

Ed. Young, a colored man well known in Newberry, was put in jail on Thursday last on the charge of stealing money from the County Treasurer's office.

Treasurer Boyd had suspected him of the stealing for some time, as he has missed various sums of money and for about sixteen years, having served for various county treasurers in that capacity.

On Wednesday afternoon Treasurer Boyd marked two \$2 bills, and put one in the drawer in the desk and one in one of the drawers in the trunk.

When Mr. Boyd came down to the office on Thursday morning, both drawers had been opened and the money was gone. He at once had Young searched and the marked money was found on his person.

Young's house was also searched, but the only things found there were lots of good clothes and plenty of tobacco.

Young and a man by which he operated the cash drawer of the desk. He was such an adept at the business that he could almost unlock it while one's back was turned. He had learned the day combination of the safe, one each used by the Treasurer and the Auditor—arranged beneath a tier of pigeon holes.

Young opened the Treasurer's drawers by using a screw driver as a lever between the lock and the pigeon hole, and it was no trouble to open them in this way.

Treasurer Boyd missed \$17 from one of the drawers at one time and \$30 at another.

The venerable on the edge of these drawers is pinched off and splintered by the instrument Young used to open them with, while the keys of the drawers on the opposite side of the safe in which the Auditor keeps his papers bear no evidence of mutilation at all.

Young had no money was kept there, and he didn't care anything about bank notes or assessment papers.

Treasurer Boyd has missed about \$100, besides stamps, and there is no telling how much money Young has taken out of the office since he has been in jail.

The Grand Jury on Tuesday found a true bill in his case, and it is probable that he will be tried to-day in the Sessions Court.

The Seasons Court. The Court began on Monday, Judge W. H. Wallace presiding. The Grand Jury returned true bills as follows:

The State vs. James Epps—forgery; tried and found guilty. Sentenced to one year in the penitentiary.

The State vs. Tom Stevens—larceny of live stock; tried; not guilty.

The State vs. Isabella McGraw—aggravated assault and battery—cutting off both ears of the victim; tried and found guilty; sentenced to three years in the penitentiary.

The State vs. Georgiana Williams—aggravated assault and battery with intent to kill; guilty; six months in the penitentiary or pay a fine of \$30 and costs.

The State vs. Ed. Young—grand larceny.

The Court disposed of other cases as follows: The State vs. Pierce Scott—aggravated assault and battery with intent to kill.

The State vs. Geo. W. Herbert—appeal from trial justice; sentence reversed and prosecution dismissed.

The State vs. Richard Schumpert—appeal from trial justice; sentence reversed and prosecution dismissed.

The State vs. B. W. Stevens—murder; not guilty.

The Grand Jury made their report yesterday morning and were discharged.

REPORT OF GRAND JURY. To His Honor W. H. Wallace, Judge presiding.

The Grand Jury would respectfully report that all matters submitted to us have had proper attention.

We would repeat our recommendations in our last report in regard to improvements in the Jail yard and also at the Poor House.

The portico in front of the Court House is in a dilapidated and rather dangerous condition, and should be repaired at once.

The Whitmire bridge is also in a dangerous condition and requires immediate attention. A small bridge near Kennerly, across a ditch, is also in bad condition.

Complaint is made of roads in Township No. 4 that have not been worked this year. On one road no overseer has been appointed. The County Commissioners seem to have failed of their duty in this respect.
