GOT THE DROP ON HIM.

A Negro Waylaid the Police but Got the Worse of the Transaction—The Negro Had Been Charged With Stealing Potatoes.

Last Saturday night some one broke into the potato house at Mrs. Werber's and stole some potatoes.

Policeman H. H. Franklin was put on the case: and Sunday he tracked the thief to where the potatoes had been hidden—or about where they had been put, and was on the lookout for the thief.

In the mean time, Mr. Franklin had John Brooks, colored, arrested on the charge. Tuesday he was given a preliminary trial before Magistrate Chappell, who bound him over on a charge of house breaking and larceny.

Brooks was represented at the preliminary by O. L. Schumpert, Esq., who claimed that sufficient proof had not been produced on which to bind over Brooks—that the State had not proven that the house had been broken into or that potatoes had been stolen.

Magistrate Chappell ruled that the point raised by Attorney Schumpert was a good one and that the statement was one of facts, yet, to his own mind he had sufficient proof of the negro's guilt to bind him over, and would do so on his own recognizance until he could see Mrs. Werber and get her sworn statement that the house had been broken into and potatoes stolen therefrom.

Wednesday night Mr. Franklin, with Mr. H. V. Vaughan, who was a special police, went to where they had located the potatoes, which was in the Jones' woods beyond Mr. J. A. Burton's residence, and near where Brooks lives. They found the potatoes, about a bushel and a peck, and put them on a negro's back for him to bring to town.

Just as Mr. Franklin jumped the fence near where the potatoes were found, he heard a noise and looked around was faced by Brooks who had raised in his left hand a scythe blade about two feet long. Brooks accosted him saying: "Who are you?" As he said that Mr. Franklin fired a shot from his pistol. The ball struck Brooks in the left arm. Brooks then stepped off and was shot in the thigh twice by Mr. Vaughan. The police, after Brooks had been wounded three times had to threaten to kill to get him to give up the blade and surrender.

At this writing Brooks is still in the guard house. The wounds are flesh wounds and neither will prove serious.

A MAD DOG. A Negro Girl Bitten—Several Dogs Killed Because They Had Been Killed. The Mad Dog Finally Killed.

Quite a commotion was caused here yesterday morning when it became known that there was a mad dog in town.

The dog was a stray one and was first observed in "Gravel Town," where it bit a little colored girl. From there it was chased up town, biting several dogs on its rounds. A large crowd gathered and followed trying to kill it, several shots being fired at it on the streets, but they all missed their aim. The dog was finally killed in the eastern part of the town by some one of the crowd.

All the dogs that was known to have been bitten by the mad dog have been killed.

Mr. Henry Caldwell's large dog was bitten and had to be killed.
