Judge Simonton has decided against the State in the Agricultural Hall case, and the State will have to turn over the property to its rightful owners. Just where the State dispensary will go has not yet been decided.

United States Senator Isham G. Harris, of Tennessee, died last week. He was the "war governor" of Tennessee, and had been in the Senate constantly for over twenty years. He was at one time speaker pro tempore of the Senate.

The first bale of cotton of this year's crop was received at Houston, Texas, on the 1st inst. This is unusually early. Only twice during the past ten years has cotton been marketed earlier. In 1893 the first bale came in on 30th June, and in 1894 on the 26th of June, and in both cases at Houston.

Mr. G. Walt Whitman filed his pledge with State Chairman Thompkins last week and tried to enter the Senatorial race, but as the pledge was received by Mr. Thompkins after the entries had closed, Mr. Whitman was debarred. The would-be candidate has written the State Chairman some spicy letters, claiming that he mailed his pledge on the same day ex-Governor Evans did his and that if one is debarred the other should be. Gov Evans, however, telegraphed chairman Thompkins as to the mailing of his pledge, while Mr. Whitman did not.

In the well-known Pinkusohn original package case, United States Circuit Judge Simonton has decided that any liquor can have agencies anywhere in the State, and sell liquor in original packages without interference so long as the constitutional regulations are observed. Almost every "original package" store has been opened in different parts of the State, and it is only a question of time before there will be open and legal opposition to every dispensary in South Carolina. Just what move the State administration will next make is hard to contemplate, and the result will be looked for with much interest.

In another column appears the announcement of Mr. J. E. Ellerbe of Sellers Marion county, for Congress. Mr. Ellerbe has been in public service for a number of years, having been elected to represent his county in the State Legislature in 1894 and again in 1896. He was a member of the late constitutional convention, and has held other offices of trust. He has the reputation of being a man of unusual ability and a good speaker. He is one that always fights for what he believes is right, and never knows what it is to give up a struggle. He is better known in the Pee Dee section of the district than he is in the lower portion, but he will be in the campaign and all may judge for themselves whether or not he is qualified to fill the seat lately occupied by McLaurin.

A recent examination of the books of the State dispensary disclosed the fact that since 1895 there have been shortages among the various dispensers to the amount of over \$16,000. Not one of the dispensers had given valid bonds, so the taxpayers lose the money. Nothing has ever been done to recover the missing money by law and it is probable nothing ever will be done. It really seems that this branch of State affairs is and has always been very loosely managed.

The Infamous Wool Schedule.
The senate computations of the equivalents for Dingley bill rates on woolen goods only need to be stated. They make opposing argument unnecessary in the mere reading. For example, the rate is 55 per cent on second class wool, 389 per cent on garnetted waste, 328 per cent on shoddy, 171 per cent on woolen cloths valued at not more than 50 cents per pound, 167 per cent on blankets more than three yards in length and valued at not more than 50 cents per pound, 212 per cent on shawls valued at not exceeding 40 cents per pound, 151 per cent on knit fabrics valued at not exceeding 40 cents per pound, 237 per cent on hats of wool valued at not more than 80 cents per pound, 419 per cent on felts of the same value, 147 per cent on plushes valued at not over 40 cents per pound, and 64 per cent on the aggregate of woolen carpets.
