The 10th Regiment of Infantry will parade at Richardson's, on Tuesday the 22d of July next.

The 7th Regiment of Infantry will parade at the Old Wells, on Thursday the 24th of July.

The 9th Regiment of Infantry will parade at Lowe's, on Saturday the 26th of July.

The Officers and Sergeants of the 2nd Brigade of Infantry, and 2nd Regiment of Cavalry, will assemble at such place as the Brigadier General of Infantry may select, on Monday the 28th of July next, and encamp "full five days," commencing at 12 o'clock, M.

The 2nd Regiment of Cavalry will parade at the place selected for the encampment, on Saturday, the 2nd of August next.

The 8th Regiment of Infantry will parade at Morrow's Old Field, on Tuesday the 5th of August.

The 6th Regiment of Infantry will parade at Lomax's, on Thursday the 7th of August.

The 4th Regiment of Infantry will parade at its usual parade ground, on Saturday the 9th of August.

The 12nd Regiment of Infantry will parade at Minton's, on Tuesday the 12th of August.

The 5th Regiment of Infantry will parade at Hunt's, on Saturday the 16th of August.

The 1st Regiment of Infantry will parade at Bruton's, on Thursday the 28th of August.

The Officers and Sergeants of the 9th Brigade of Infantry, and the 9th Regiment of Cavalry, will assemble at Gaffney's Old Field, near Limestone Springs, on Monday the 1st day of September next, and encamp "full five days," commencing at 12 o'clock, M.

The Officers and Sergeants of the 6th Brigade of Infantry, and 6th Regiment of Cavalry, will assemble at Yeague's, on Monday the 15th of September, and encamp "full five days," commencing at 12 o'clock, M.

The Commissioned and non-Commissioned Officers of the Regiments ordered for Review, will assemble the day previous at the place of rendezvous, of their respective regiments, for drill and instruction.

The review of each Regiment will take place at 12 o'clock, M.

The Brigadier Generals are charged with the extension of this order.



To all and singular the Managers of the General Elections, for the several Districts of the State of South Carolina:

WHEREAS the Legislature of South Carolina, at its late Session, did pass an Act to provide for the election of Members to a SOUTHERN CONGRESS; And whereas, said Act requires the Executive Authority to issue Writs of Election to the Managers of Elections; I do hereby require you, and each of you after giving legal notice and being duly added, to proceed to hold an election on the 2d Monday of October next, and day following, for two Deputies to represent your respective Congressional Districts; and after having determined on persons duly elected, you will certify the same according to law, to the Governor for the time being.

Given under my hand and the seal of the State, in Columbia, this 1st day of June, in the year of our Lord one thousand eight hundred and fifty-one.
