PLAIN WORDS.

The Sacramento Bee addresses the following plain words to the voters of Sacramento:

Whatever Congress may do in the way of regulating foreign immigration in the future it is tolerably certain that the immigration laws as they stand will remain much longer in force.

The power to decide the terms on which aliens may settle in this country rests with Congress. But in a number of States have usurped that power, without renunciation from Washington.

The Federal law declares that an alien shall not exercise the right of suffrage until he has resided in the country, and unless two years before he applies for naturalization he has declared his intention to renounce his former allegiance to the government of his native country.

The law further provides that the applicant for the right to vote must be a person of good moral character, and of sufficient intelligence to understand the duties of citizenship.
